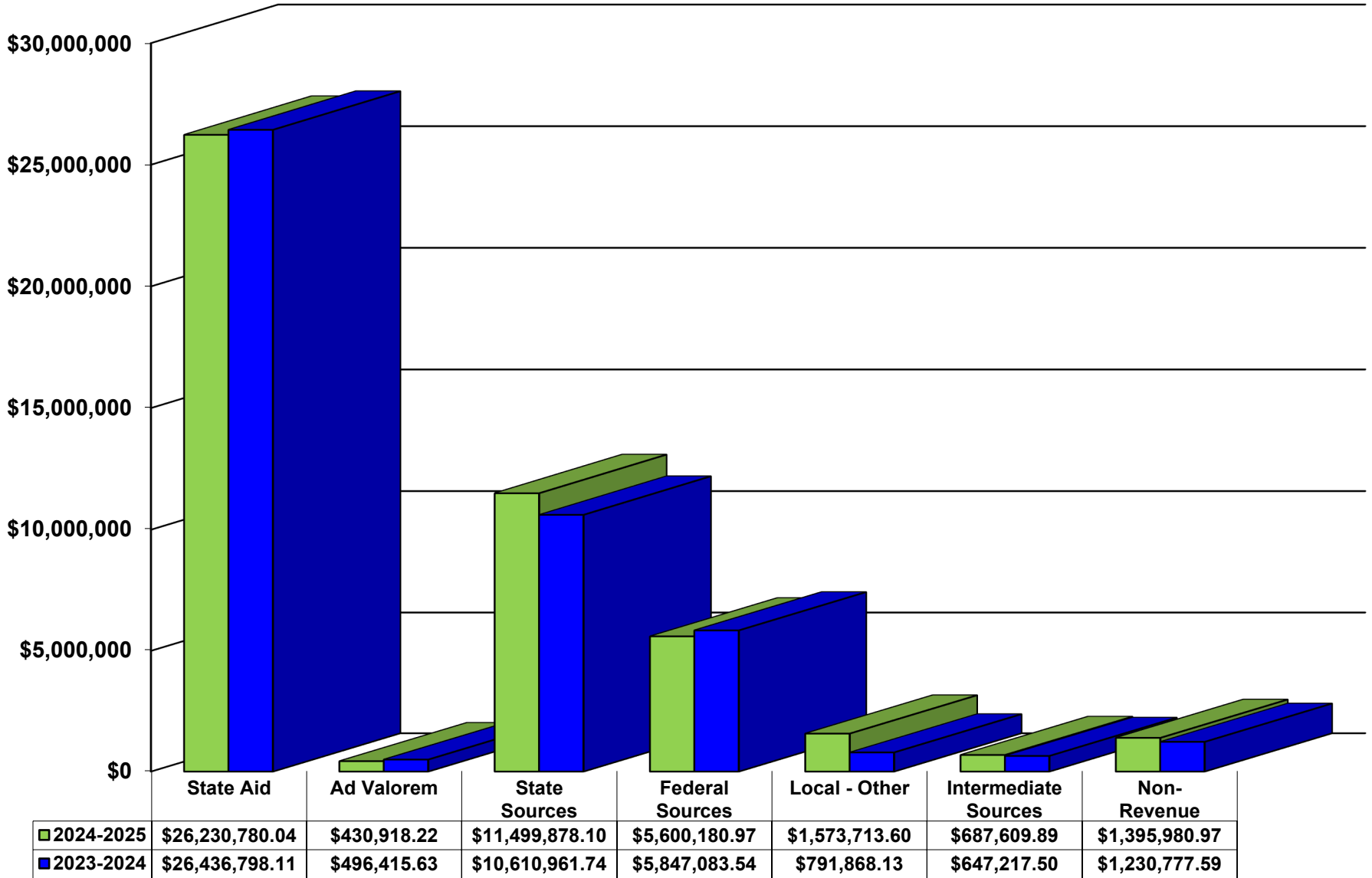

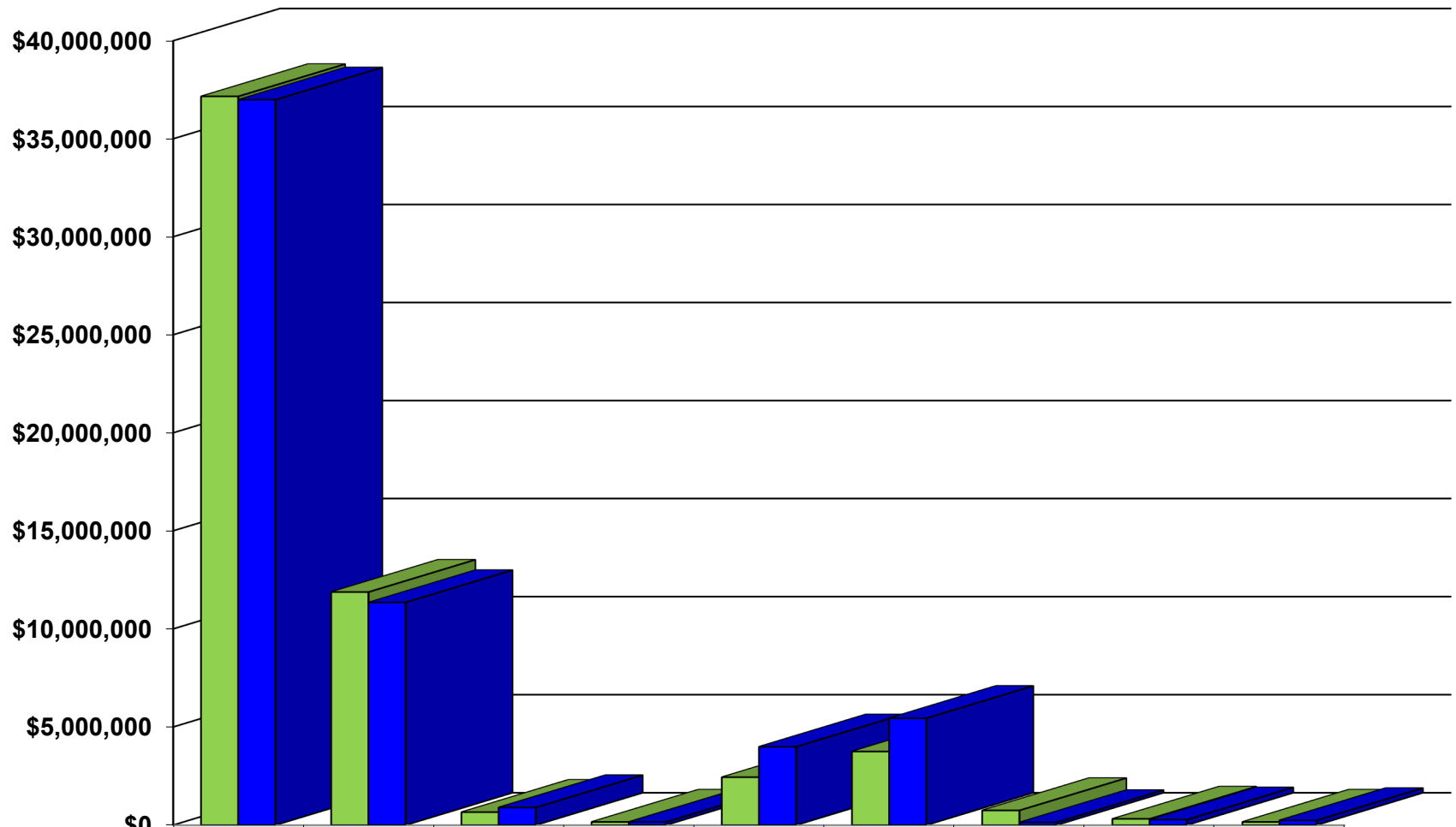

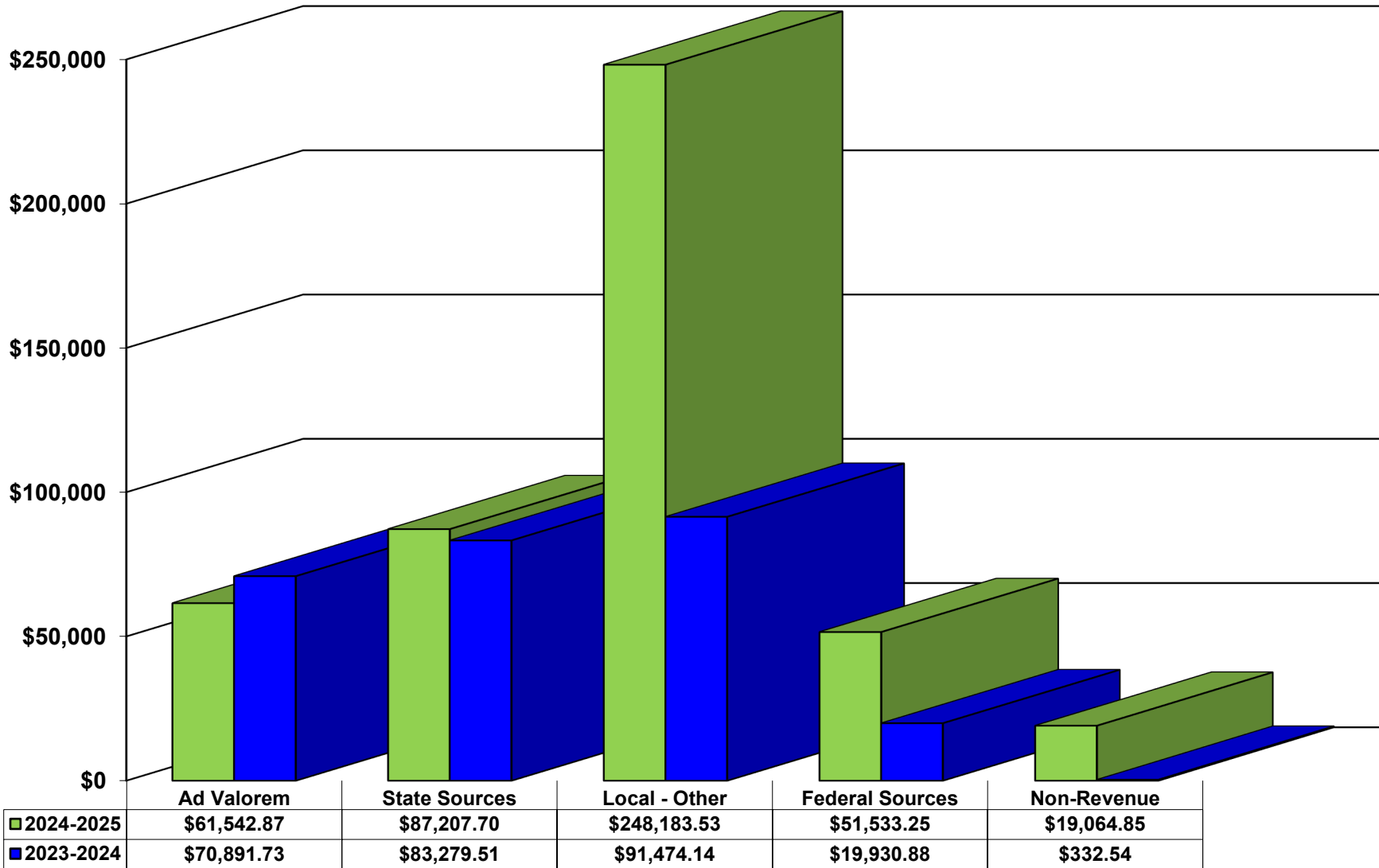

Year-to-Date Revenue

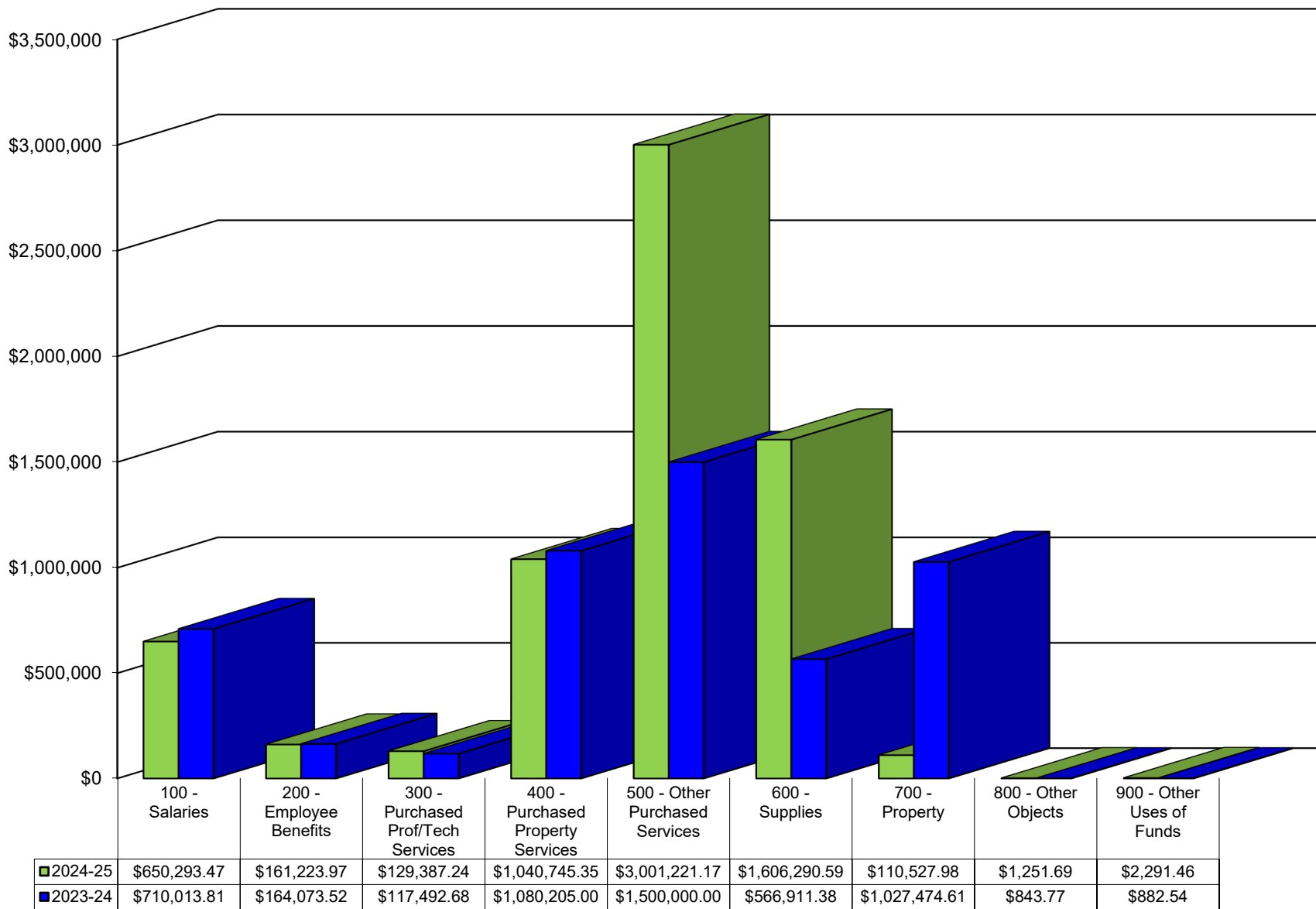

November 2024



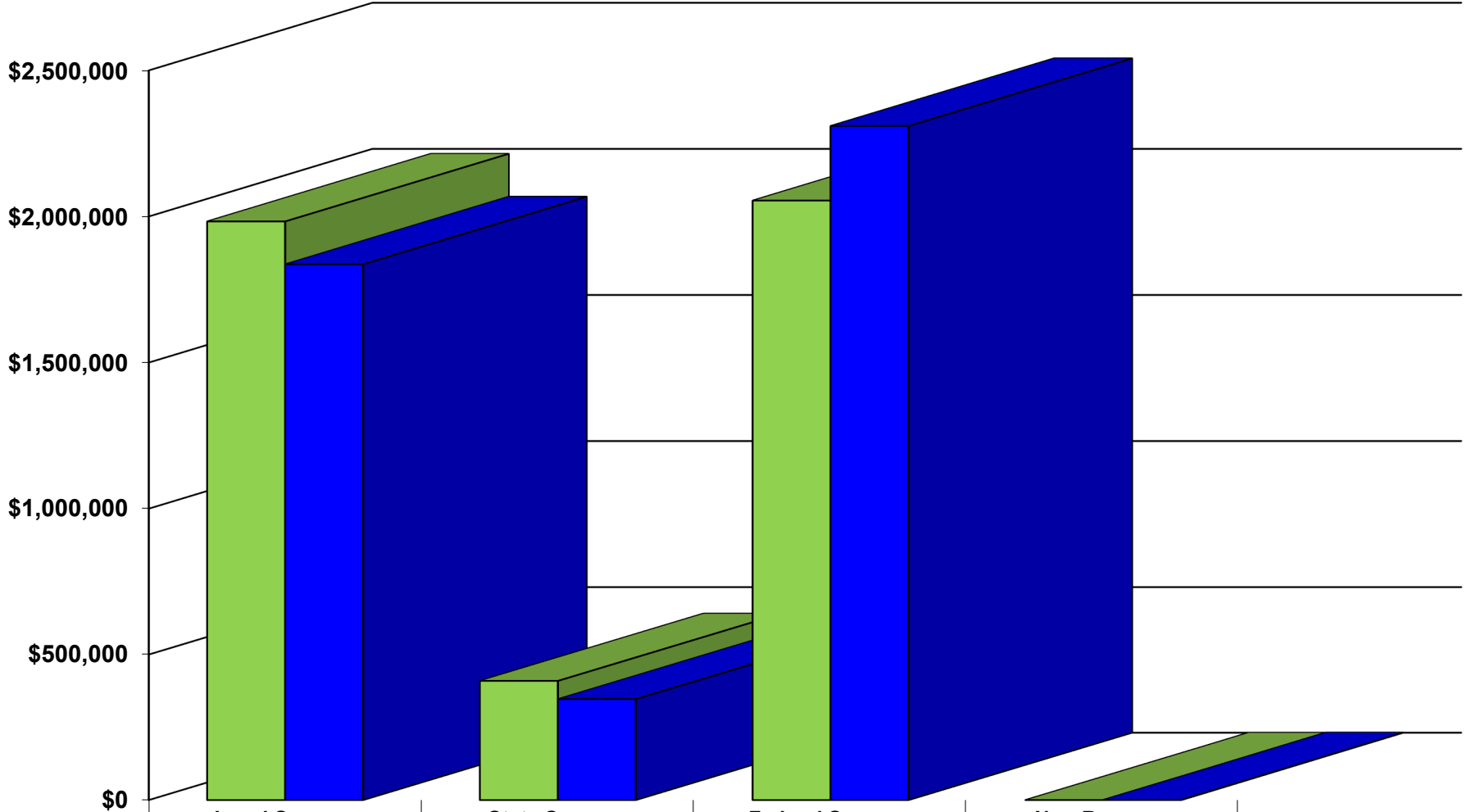

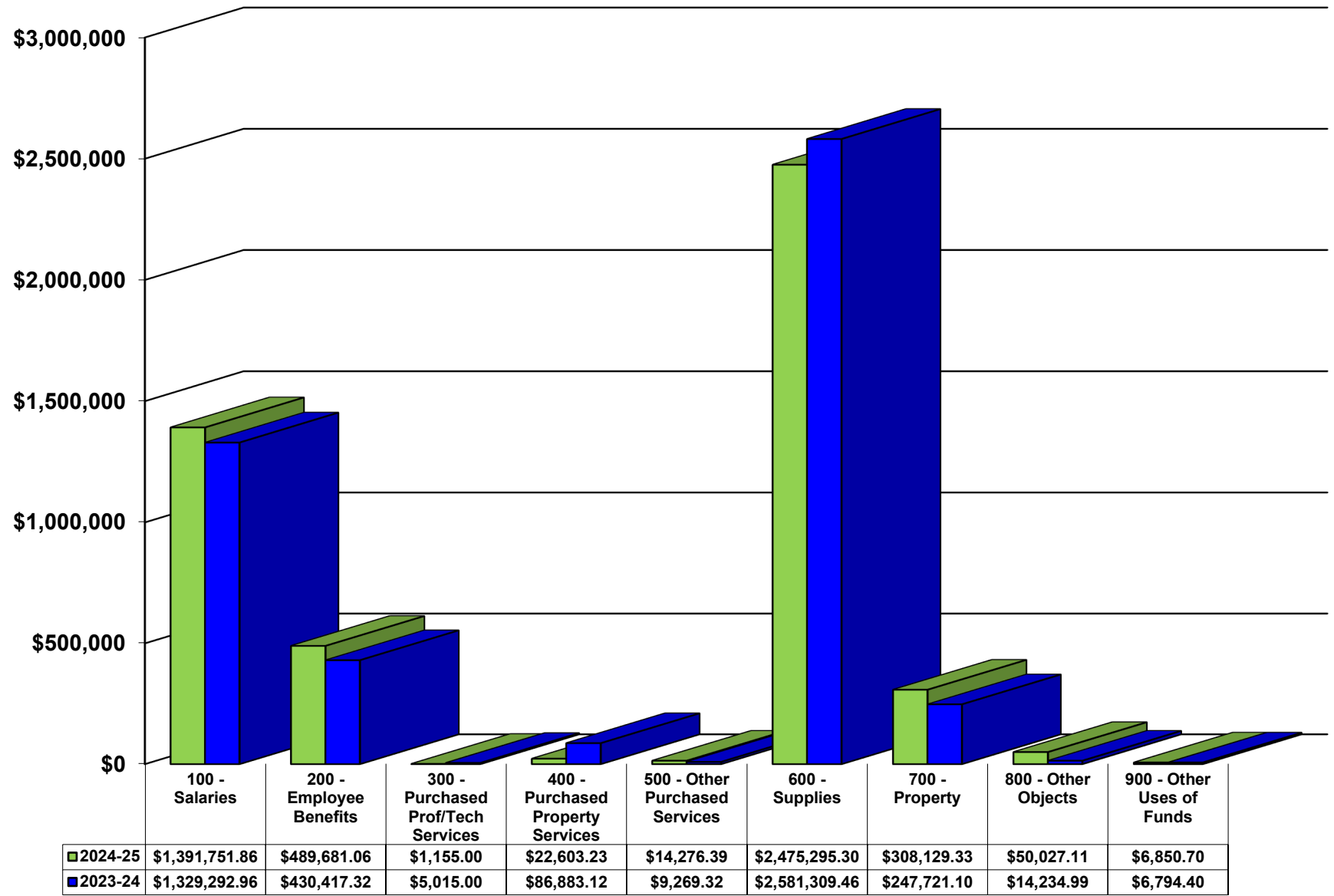
