#### **SUMMARY**

The district's move to using propane as an alternative fuel source has caused a need for on site fueling solution for the new propane buses added to the fleet. ### 1. Purpose

The Supplier agrees to provide propane to the Client for their 1000-gallon propane auto gas dispenser.

# 2. Pricing and Payment Terms

- The propane price will be based on the Tulsa refinery's current price, which changes daily. Today's price is \$1.39 per gallon
- The cost of propane will be **established at the time of delivery**, and the Client will be invoiced and charged at the time of delivery, in line with standard industry practices.
- The Client agrees to make payments within 30 days of receiving the invoice.
- Fuel is **not billed by usage** but by delivery.

# 3. Tank Monitoring and Supply

- The Supplier will install a **tank monitor** on the Client's propane dispenser to monitor usage.
- The Supplier agrees to keep the tank filled based on the monitored usage.
- The Supplier will also **test the tank with fuel upon delivery**, as is customary practice.



# 4. Maintenance, Upkeep, and Regulatory Compliance

- The Supplier will be responsible for the **maintenance**, **upkeep**, and ensuring the **regulatory compliance** of the propane dispenser.
- All maintenance and inspections necessary to meet **regulatory standards** will be handled by the Supplier to ensure safe and legal operation of the equipment.

# 5. No Additional Fees

• The Supplier will not charge any **delivery fees**, **HazMat fees**, or other surcharges for the propane deliveries.

#### 6. Termination

• This contract may be terminated by either party with [30 days' notice] in writing.
