About H5P.com

Hosting

H5P.com is a Software as a Service (SaaS) version of the open-source software platform H5P. It is created by the H5P Core Team in Joubel and hosted on state-of-the-art infrastructure provided by Amazon Web Services (AWS). The system is hosted in a way that so far has produced very high availability and scalability.

The system has automatic failovers for almost every component and automatic scaling of almost every component. It is not possible to build an IT system that cannot go down, and should the system go down and not be able to repair itself automatically H5P experts will get an automatic phone call 24/7. The availability SLA is on 99.9 % uptime.

Features

H5P.com includes all the features of H5P and in addition integrations with third party tools to offer all the features needed for an organization to succeed with H5P. From the start this includes tight integrations with LMSs like Canvas, Blackboard and Brightspace allowing users of these systems to both manage and experience H5P content from within the systems without having to log on to H5P.com. Grades are also stored in the LMS, and H5P offer additional reporting as an extra package where the price is based on the number of learners.

H5P.com allows users to manage their content by organizing it in folders, adding collaborators, cloning, controlling visibility and more. H5P.com also includes an easy-to-use user management section for administrators.

Hand in hand with the H5P roadmap

The creators of H5P.com are also the creators of H5P and will make sure that H5P.com walks hand in hand with the H5P open-source project. One example is the upcoming metadata features that will be added to H5P. This means that the only metadata that is added to H5P.com are the folders. H5P.com will use the open-source project's new metadata internally in H5P.com as well. This includes the ability to add and filter on discipline, level, licensing, tags and content types. H5P.com will also use the same UI for filtering content as the upcoming H5P Content Hub that will be available for every user of H5P.
