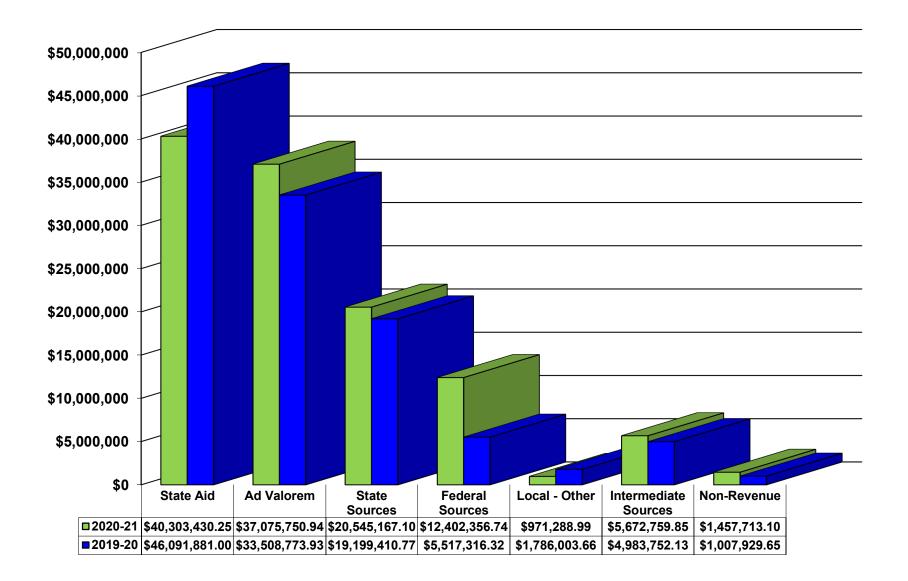

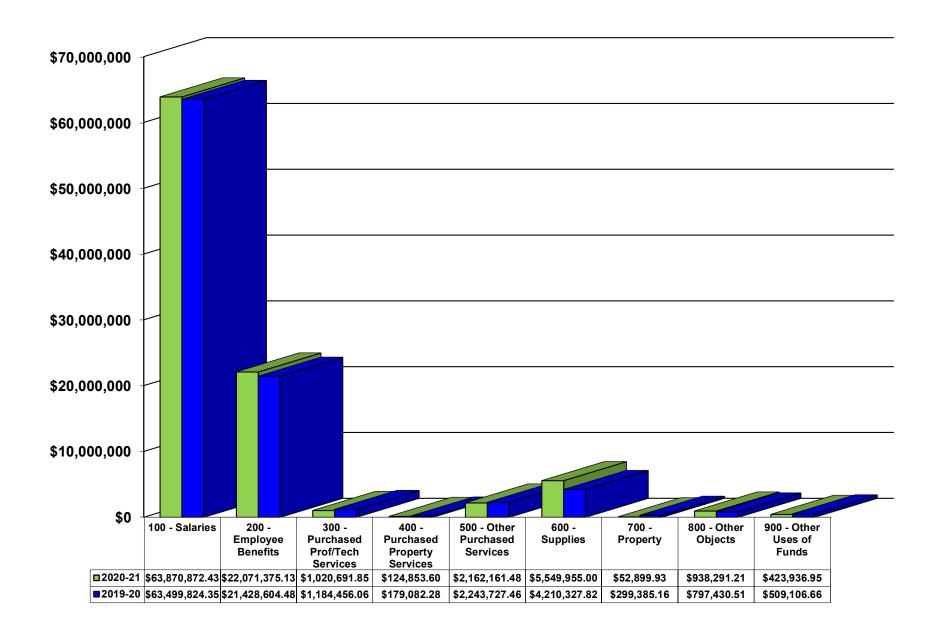

## General Fund Year-to-Date Revenue April 2021



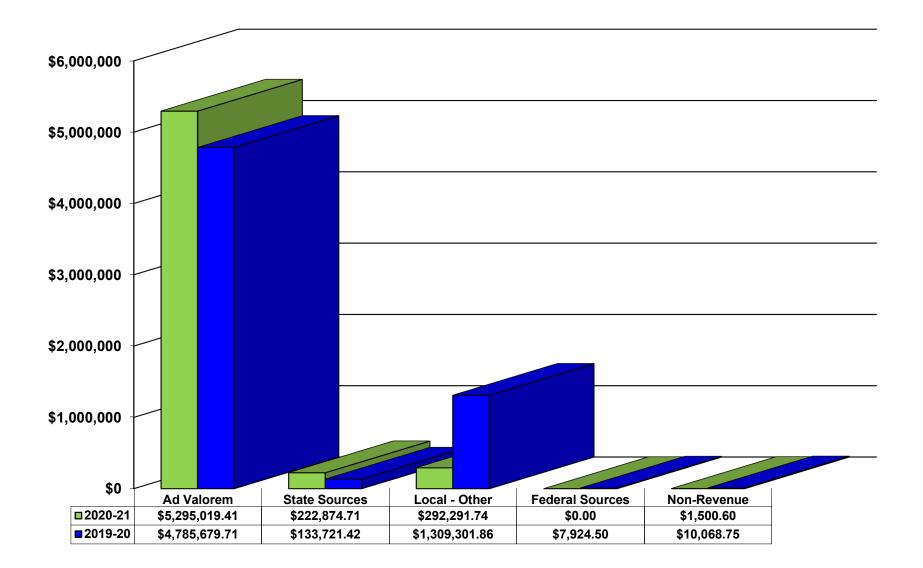
**General Fund** Year-to-Date Expenditures April 2021



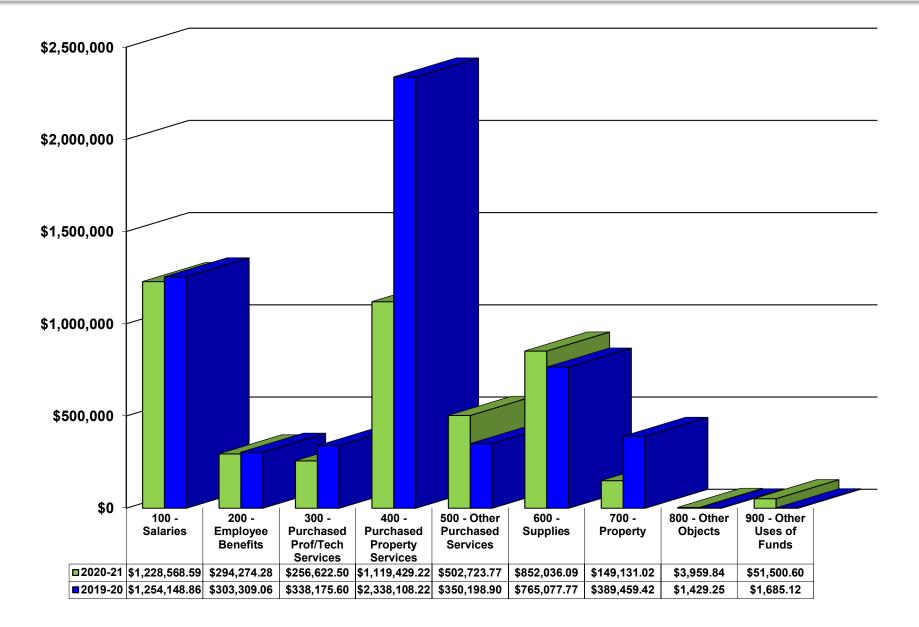

Building Fund Year-to-Date Expenditures April 2021

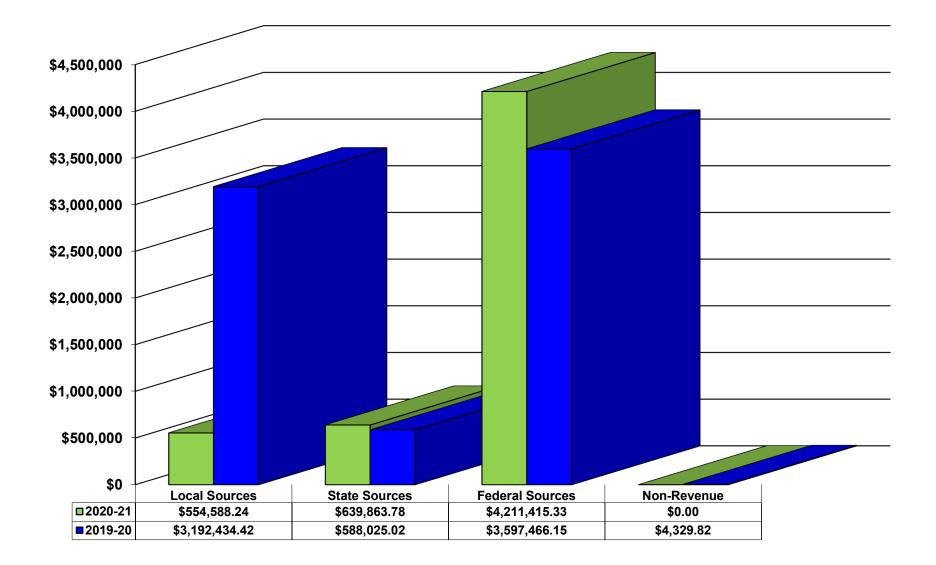

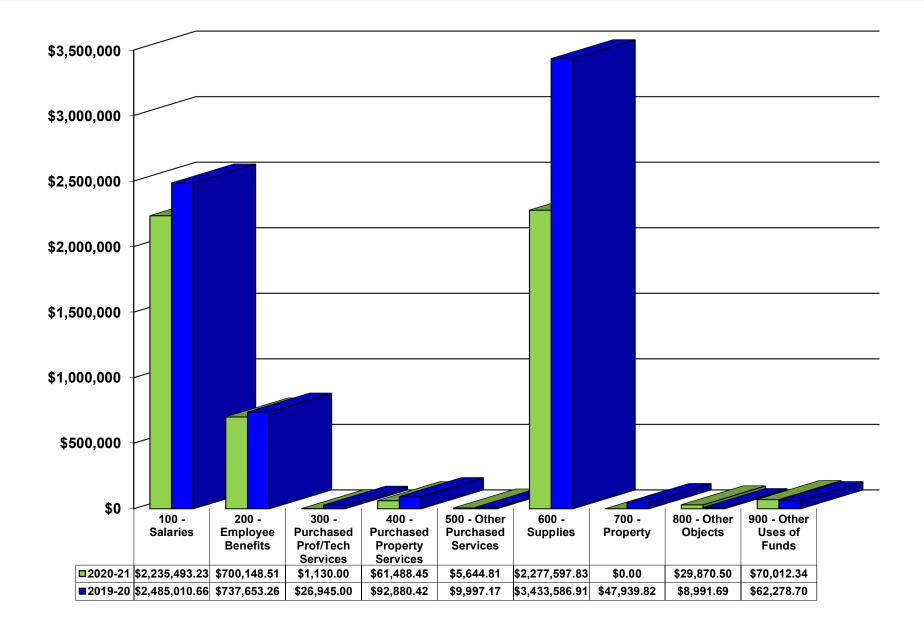
