MEMORANDUM OF AGREEMENT BETWEEN THE OKLAHOMA ARMY NATIONAL GUARD AND THE LANDOWNER

SUBJECT: Land Use Agreement

- 1. This agreement made this 17th day of October 2022, between Rhoades Elementary School (Landowner) and Co C 3-140th Aviation Regiment, units of the Oklahoma Army National Guard (Guard).
- 2. The Landowner in consideration of the covenants and agreements hereinafter set forth does by these presents grant to the Guard the non-exclusive right to use the following described property: Rhoades Elementary School, 320 E Midway St., Broken Arrow, OK 74012.

Additional Location Description:

- 3. This agreement is for the period beginning 10 November 2022 and terminating on 10 November 2024. Said agreement may be terminated by either party giving the other party ONE-DAY verbal or written notice.
- 4. It is understood that the Guard intends to use the property to conduct training. Said training shall include a static display of a National Guard Airframe that can include a UH60 Blackhawk or an UH72 Lakota. The training will consist of a approach to a landing and a takeoff from the event.
- 5. Except as stated in this paragraph, it is understood that the Guard will not store or permit any other persons to store on the property anything which would be detrimental to the property or a fire hazard or which would endanger personnel or constitute a public nuisance. Exceptions: **NA**
- 6. Except as stated in this paragraph, it is understood that the Guard at its own expense will remove or cause to be removed all Guard property which it may have placed on the Landowner's property.

Exceptions: NA

- 7. It is understood that the Guard will be responsible for the maintenance of order and safety in connection with the use of Landowner's property.
- 8. Except as stated in this paragraph, it is understood that at the end of this agreement, or sooner terminated thereof, the Guard shall give peaceable possession to the Landowner in the same condition as the property was in at the time of execution of this agreement, the usual wear and tear by the training described above and damage by the elements excepted.
