Description of Services

This proposal reflects alarm response services for 15 responses per month with security coverage hours between 6:00 pm to 6:00 am seven days a week. Each additional alarm response will be charged to the client at the rate of \$25 per response. Signal 88 will provide a phone number for distribution to individuals indicated by the client. These responses by our patrol officer are called "Alarm Responses". Alarm responses are between the hours of the service agreement. If an alarm response requires standing guard for more than 60 minutes the client will be charged at the hourly rate of \$20.

Officer team will be notified of alarm call via Signal 88 Dispatch. An Officer will arrive on premise in a fully marked, high visibility Signal 88 vehicle. Dispatched officer will exit vehicle and foot patrol the exterior of the building with focus on the reported location. Dispatched officer will utilize 88Edge to log a report regarding the incident.
