Applicant's Purpose, Goals and Organizational Structure:

The general purposes for which this Organization has been established are as follows:

- a) To arouse and maintain an enthusiastic interest in all phases of the Broken Arrow Public Schools (BAPS) Band Program (Band Program).
- b) To help support the band program's financial needs as determined by the Director of Bands.
- c) To support the Band Program and the BAPS in building and maintaining the highest quality instrumental music program possible.
- d) To enable parents and booster club members to support with time and money in an organized fashion that will benefit the students and the Band Program as a whole.

Describe how the School District and its Students will benefit if the Applicant is Sanctioned:

This Organization will be formed for the purpose of performing all things incidental to, or appropriate in, the foregoing specific and primary purposes for the Band Program grades 6-12. The organization would conduct various fundraising activities generating funds to support student activities. Removing the financial restrictions of the BA school district policy would allow parent volunteers more flexibility in choosing activities and vendors. This flexibility would result in a faster response to the needs of the BA Bands organization, and a more efficient use of funds raised by volunteers. The ability to tap into new resources from a 501C3 non -profit Organization opportunity is exciting and opens many doors. As a whole the focus for sanctioning is to help better effect the student's ability to perform and learn without district boundaries inhibiting them.

Applicant also acknowledges that, in order for the School District to consider whether to maintain the sanctioning action of Applicant, Applicant shall provide to the Board of Education, upon request, on an annual basis, by August 1 of each year, the audit report, if any, for Applicant's recently ended fiscal year, prepared by an independent accounting firm.
