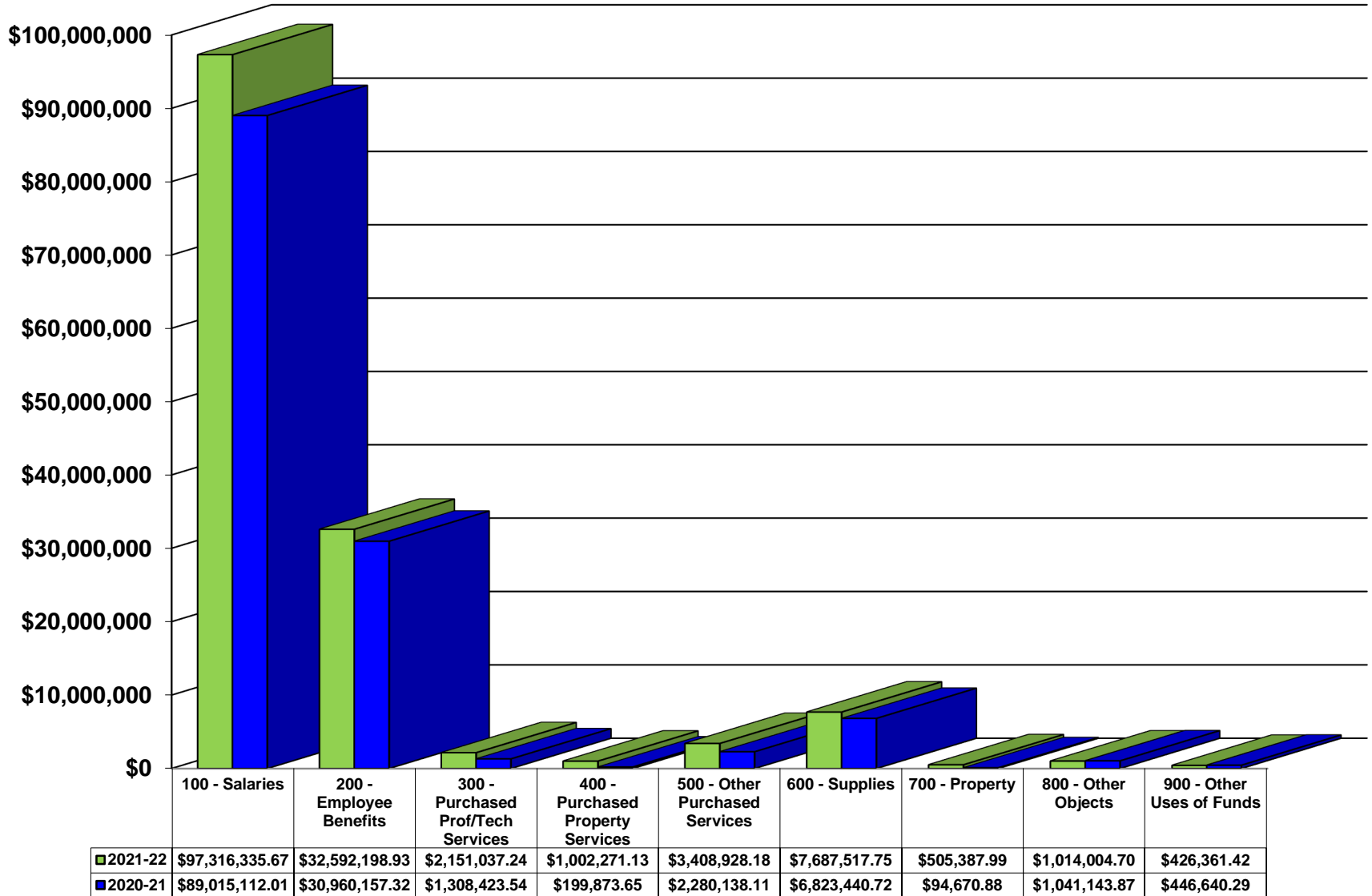

June 2022



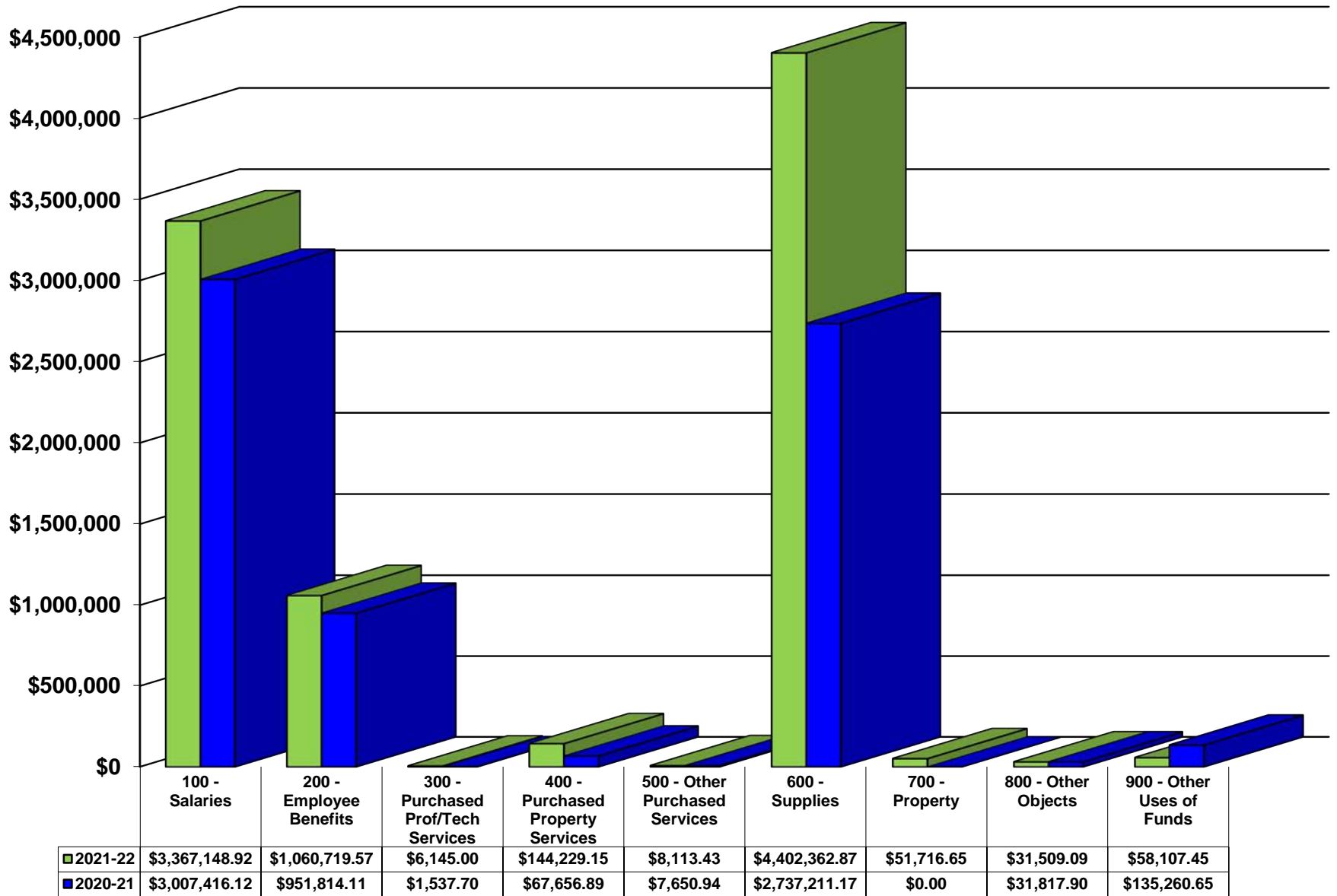
