In speaking with Elaine last night regarding BA students home population that we are certain we can provide fixed internet service to, we feel it prudent to provide you some pre-liminary application request content (i.e. application deadline being 8/13). We know we are capable of covering 80% or 15,113 BA student homes with fixed internet. That number will increase slightly when we complete re-analyzing 20% or 3753 BA student homes

When submitting your 471 form in the EPIC portal to USAC for ECF funding, use \$35 + \$5 for taxes x 15,113 BW qualified households = \$604,520per month or \$7,252,240 1 yr funding to cover students free internet from ECF fund. Good Afternoon Ashley.

Back in the saddle today from PTO, and Elaine is handing lead communications back to me. Lake Tahoe is still super glorious, lots of pictures saved on my iPhone to show and tell!

- 1. Reply The full BW capacity of each address is in the last column. We will provide the highest level possible, but not over 50 MBPS.
- 2. Reply Our goal was to help in the cross referencing of our data back to the original file. Therefore, we returned the list as we received it, but with BW capacity at on net addresses. Specifically we took your list and saved "as is" but with "unique-identifiers". Then we created a second one that was scrubbed and sent for address qualification. We then took that data and overlayed it back to your original list. I am not 100% sure of why the same address that showed "n/a". I suspect that it was originally "scrubbed" out and then failed to pick up the BW.

At a high level it appears that we can deliver fixed home internet to 80% of BA students. 20% of BA student homes showing N/A. I am making an effort to see if we can re-run that smaller group through our batch qualifying tool. Will advise with updates shortly

I hope that helps. Please let us know if you prefer to jump on a quick call to review further.
