SALES AGREEMENT

This contract agreement ("Agreement") dated October 14, 2022, is made between Broken Arrow High School Robotics, and Ozark Delight Candy Company, with an office at #1 Lollipop Lane, Prairie Grove, AR 72753, for the purpose of setting forth the exclusive terms and conditions by which Broken Arrow High School Robotics desires to acquire Lollipops to sell as a fundraiser.

In consideration of the mutual obligations specified in this Agreement, the parties, intending to be legally bound hereby, agree to the following:

1. Services. BAHS Robotics retains the Iollipops, and Ozark Delight Candy Company agrees to send the suckers upon, this agreement between Broken Arrow Public Schools, Broken Arrow High School Robotics, and Ozark Candy Company.

2. Consideration / Compensation:

- (a) In exchange for the full, prompt, and satisfactory transition of the designated product quantity (16 bags of lollipops) to be rendered to BAHS Robotics, Ozark Delight Candy Company shall receive within 30 days, full and complete compensation in the sum of \$475.70 to be paid at the completion of the Services.
- **(b)** Ozark Delight Candy Company is not entitled to receive any other compensation from Broken Arrow Public Schools or BAHS Robotics. Except if another agreement is made between the parties for more products

6. Termination:

This Agreement shall be effective on the date hereof and shall continue until terminated by either party upon 14 business days' written notice.

8. General:

- (a) This Agreement does not create an obligation on BAPS or BAHS Robotics to continue to retain Ozark Candy Company beyond this Agreement's termination. This Agreement may not be changed unless mutually agreed upon in writing by both parties.
- **(b)** This Agreement contains the entire agreement between the parties hereto with respect to the transactions contemplated herein. The language of all parts of this

agreement will in all cases be construed as a whole in accordance with its fair meaning and not for or against either party.

(c) All notices provided for in this Agreement shall be given in writing and shall be effective when either served by hand delivery, electronic facsimile transmission, express overnight courier service, or by registered or certified mail, return receipt requested, addressed to the parties at their respective addresses as set forth at the beginning of this Agreement, or to such other address or addresses as either party may later specify by written notice to the other.
