This shall serve as the agreement between Broken Arrow Alumni Association and Broken Arrow Public Schools – Tiger Threads to sell Broken Arrow Alumni apparel or accessories. This contract will be in place starting May, ^{7th} 2024 through June 30th, 2024. A new contract for 2025 school year will be proposed in July of 2024.

Broken Arrow Alumni Association shall provide to the Tiger Threads apparel and accessories on consignment. All apparel and/or accessories will adhere to the District's approved colors and school policies. In coordination with Tiger Threads, the Alumni Association will provide new or refilled product upon request. The Alumni Association requests that Tiger Threads sells these provided items at a price set by both parties that is appropriate and in line with the store. The Alumni Association will not sell items that compete directly with Tiger Threads, school sites, or sports teams. It is the responsibility of the Alumni Association to keep items stocked.

Broken Arrow Public Schools – Tiger Threads will provide store space, advertisement, and online access to sell the apparel and accessories provided by the Alumni Association. Tiger Threads will be provided a commission from the point of sell at an agreed upon price not to exceed 25%. Tiger Threads will not sell items that compete with the Alumni Association logo. Tiger Threads will be responsible for tracking the point of sell and will reconcile with the Alumni Association representative(s) monthly to ensure that items can be restocked and proceeds distributed appropriately. Tiger Threads will not be charged for any unsold items.

Broken Arrow Alumni Association is recognized as a 501c3 organization.

Either party may cancel this agreement with a 30-day notice in writing, if either party believes it would be in the best interest of their organization to break the agreement.
