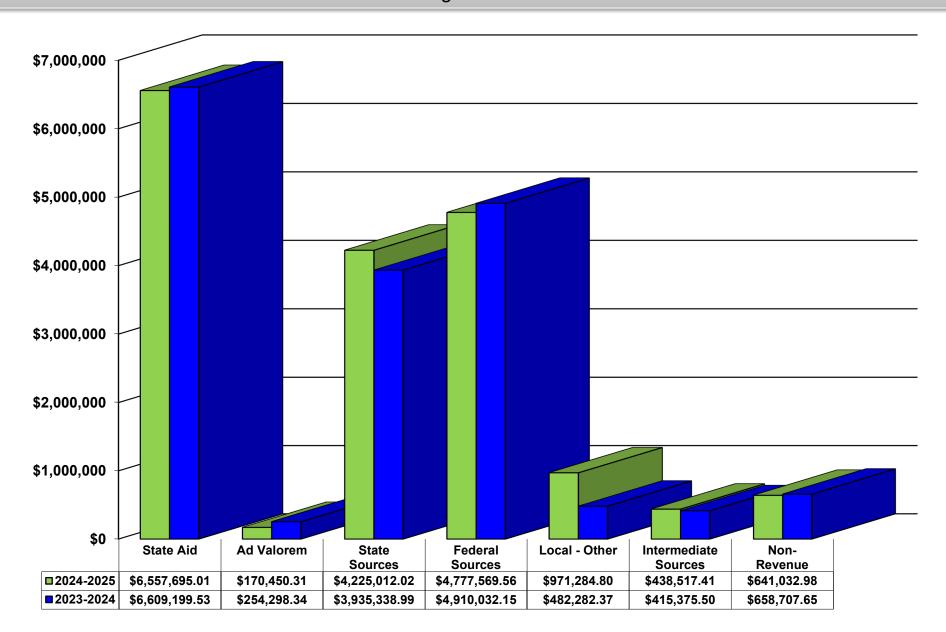

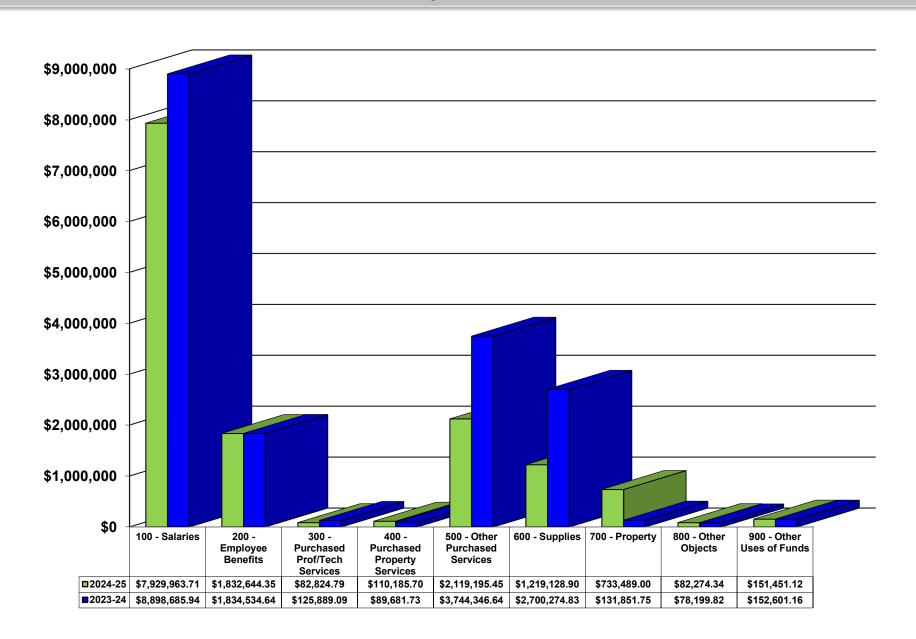
General Fund

August 2024

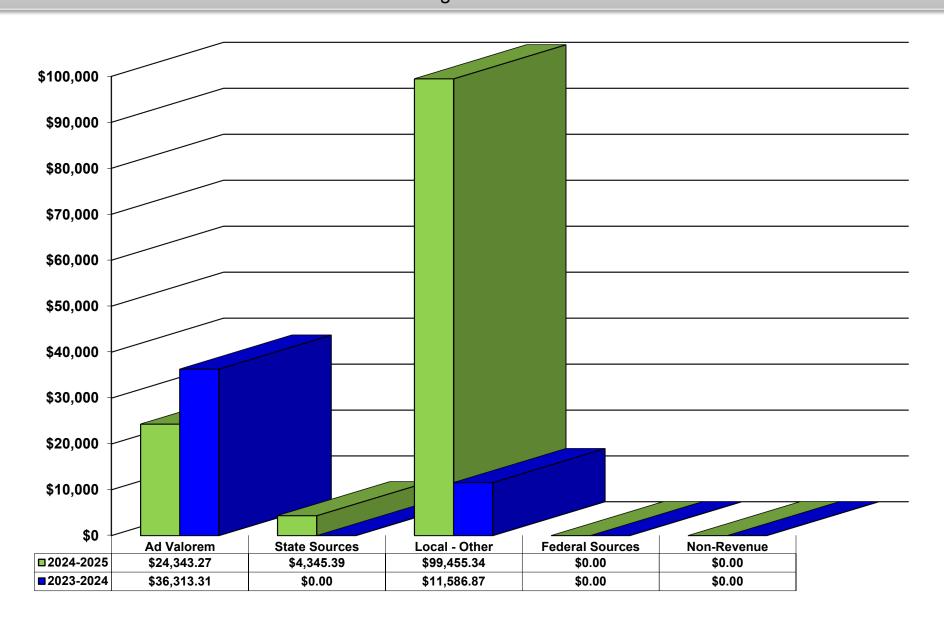

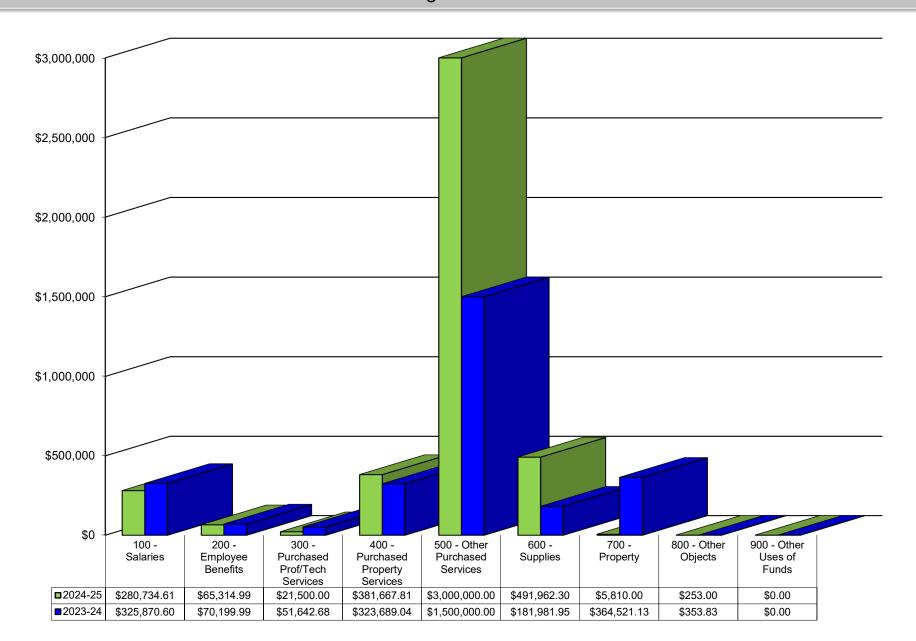
Building Fund

Year-to-Date Expenditures August 2024

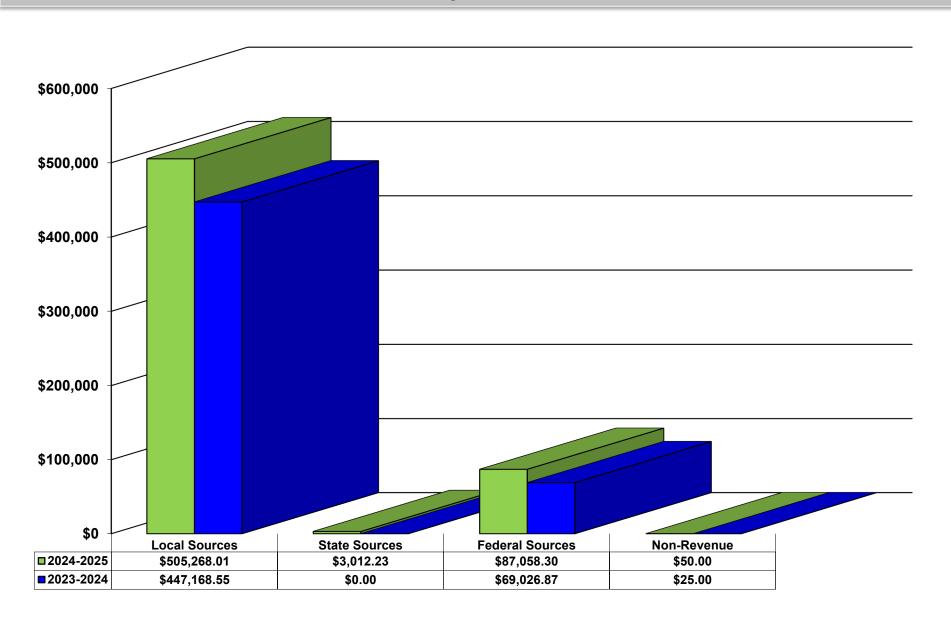

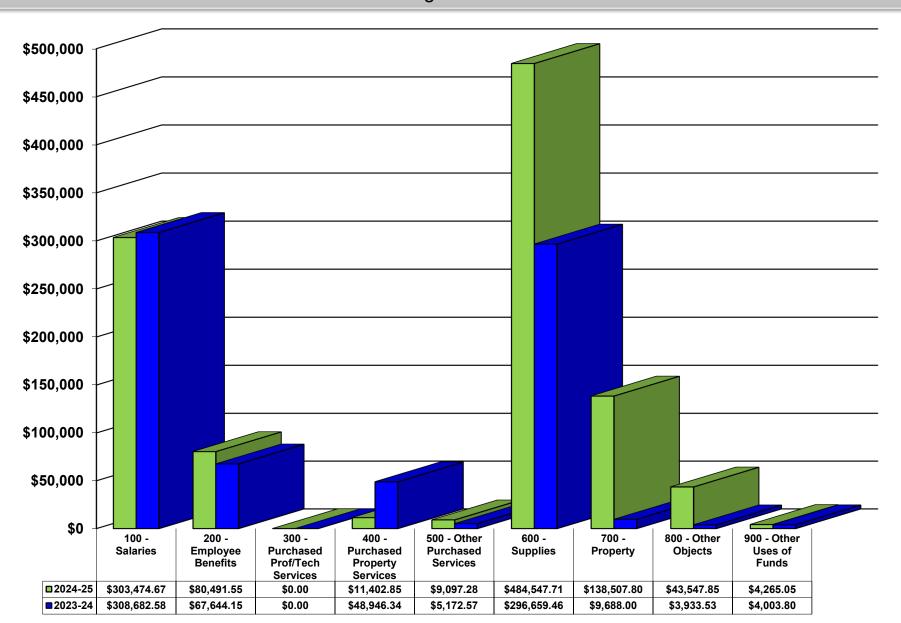
Child Nutrition Fund
