This agreement is entered into between Palmer Addiction Recovery Services and the Broken Arrow Public School. The Purpose of this contract is to provide Professional Substance Abuse Education and Counseling Services.

Palmer will provide a Licensed Counselor or Case Manager II once a week for one (1) hour, per school site, to teach a substance abuse education group to students with a drug related offense.

Palmer will provide a Licensed Counselor or Case Manager II once a week for one (1) hour to provide substance abuse education/counseling to any student participating in competitive physical activities who did not pass a drug test. Palmer will provide BAPS with background checks of the counselors or case managers that will have access to BAPS students.

Broken Arrow Public Schools will provide a space for groups and individual sessions to be held.

Broken Arrow Public Schools will have any parent sign the Palmer consent form and give copies to Palmer prior to services rendered.

## II. Cost of Service

There will be no cost for this service.

#### III. Duration of Contract

This contract will be valid for the FY 24/25 school year. July 1st, 2024-June 30, 2025.

### IV. Cancellation

This contract is subject to termination upon thirty (30) days advance written notice by either party.

#### V. Amendment
