CONTRACT FOR ATHLETIC TOURNAMENT CONTEST

This agreement, made in duplicate on May 4, 2021, between Broken Arrow (OK) and the VisitMesa.com Basketball Challenge Tournament Committee ("VMBC") for a high school basketball tournament in Mesa, AZ.

First: Contract states Broken Arrow (OK) will play four games (one per day) on December 20-23. School will arrive in Arizona on December 19 – unless other arrangements are agreed upon. Team will stay at the Hyatt Place Phoenix-Mesa (the official tournament hotel) for the duration of the event. While those outside of the official party may stay at another property, the official party must stay at the designated host hotel. The penalty for breaking this guideline is approximately \$1000.

Second: The VMBC agrees to offer the following items:

- \$1000 Cashier's Check available prior to the conclusion of tournament.
- Breakfast each morning at the host hotel
- Access to gym time if you'd like to conduct a walk-through or shoot-around.
- Game format of two, 16-minute halves.
- Three-person officiating crews
- Stats at halftime & end of game for coaching staff
- 35-sec shot clock will be used
- T-shirts for official team party (15)
- Waiving of the tournament entry fee (\$450)

Third: Each game will follow NFHS rules and guidelines.

Fourth: Broken Arrow (OK) participation is guaranteed upon the VMBC receiving this agreement. Please sign and return no later than August 27. Failure to do so may affect the original commitment. You will receive e-mail and written confirmation once your agreement is received.
