

AGREEMENT

Issue Date: March 3, 2021

This will confirm the agreement between Hypnosis Events, LLC, and Broken Arrow High School (Client), for the presentation of Erick Känd's Comedy Hypnosis Show.

LOCATION: Broken Arrow High School Gymnasium, 1901 E Albany St, Broken Arrow, OK 74012

PERFORMANCE DATES:

Show #1, Thursday, May 20, 2021 at 11 pm

Show #2, Friday, May 21, 2021 at 12:30 am (very early morning)

LENGTH OF SHOW: 60 minutes

EXPECTED ATTENDANCE: 500 (each show)

FEE: \$2832.50

Parent Permission: Client *may* send a note home stating if they do NOT wish their child participating, please sign and return. A child without permission should not be present until after the hypnosis induction is complete.

Client to provide the following:

- 12-20 straightback, *ARMLESS*, banquet chairs (standard folding chairs are also acceptable)
- Cleared performance area with adequate lighting and good audience visibility. (If used, a riser stage should measure at least 24' wide x 16' deep).
- Wireless HAND-HELD microphone.
- Professional DJ type PA Sound System with mixer input for iPod.

A deposit in the amount of **\$1416.25** is to be paid with the signed agreement to secure the above date. Please make checks payable to Hypnosis Events, LLC. The deposit is non-refundable if the performance is cancelled within 45 days of the date of your event. The remaining balance of **\$1416.25** is due on or before the date of your event. If payment is not received the day of the show, client agrees to pay an additional 20% penalty added to the stated fee.

This Agreement is valid 10 days after the issue date above. If the signed Agreement is not received on or before that date, the Agreement becomes void and Hypnosis Events, LLC, reserves the right to schedule another engagement on the date that is being held for the above event.

Either party may cancel the Agreement by providing at least 45 days advance written notice to the other party. In the case of proper and timely cancellation, any deposit shall be refunded to the client within 10 days of receipt of the notice of cancellation. Artist reserves the right to provide a substitute performer on at least 5 days written notice, should a long term engagement of at least 7 days arise which conflicts with the performance scheduled by the Client. In such a case, Client shall have the option to either allow the substitute performer to complete the engagement at the full agreement price, or to cancel the engagement and receive a full refund of any amounts paid.

Other than the circumstances outlined above, neither party to this Agreement shall have the right to cancel this Agreement, except in the case of a mutual agreement by the parties to cancel, made in writing and signed by both parties, or in the event of an Act of God. Hypnosis Events, LLC, shall have the final determination of what constitutes an Act of God allowing cancellation by a party. The attempt by one party to cancel this Agreement in any manner other than those specifically allowed by these terms shall be a breach of this Agreement.
