
Compensation - \$11,000 all inclusive, paid \$5,500 October 2021 and November 2021, for band choreography.

Terms and Conditions

In the event James W. Moore fails to perform under the terms of this agreement as a result of events or circumstances outside of his control, such as illness, acts of nature, etc., James W. Moore agrees to offer services at a later date, providing such can be rescheduled. James W. Moore will notify BAPS immediately with any circumstances or event that will prevent him from performing under this agreement.

Termination
