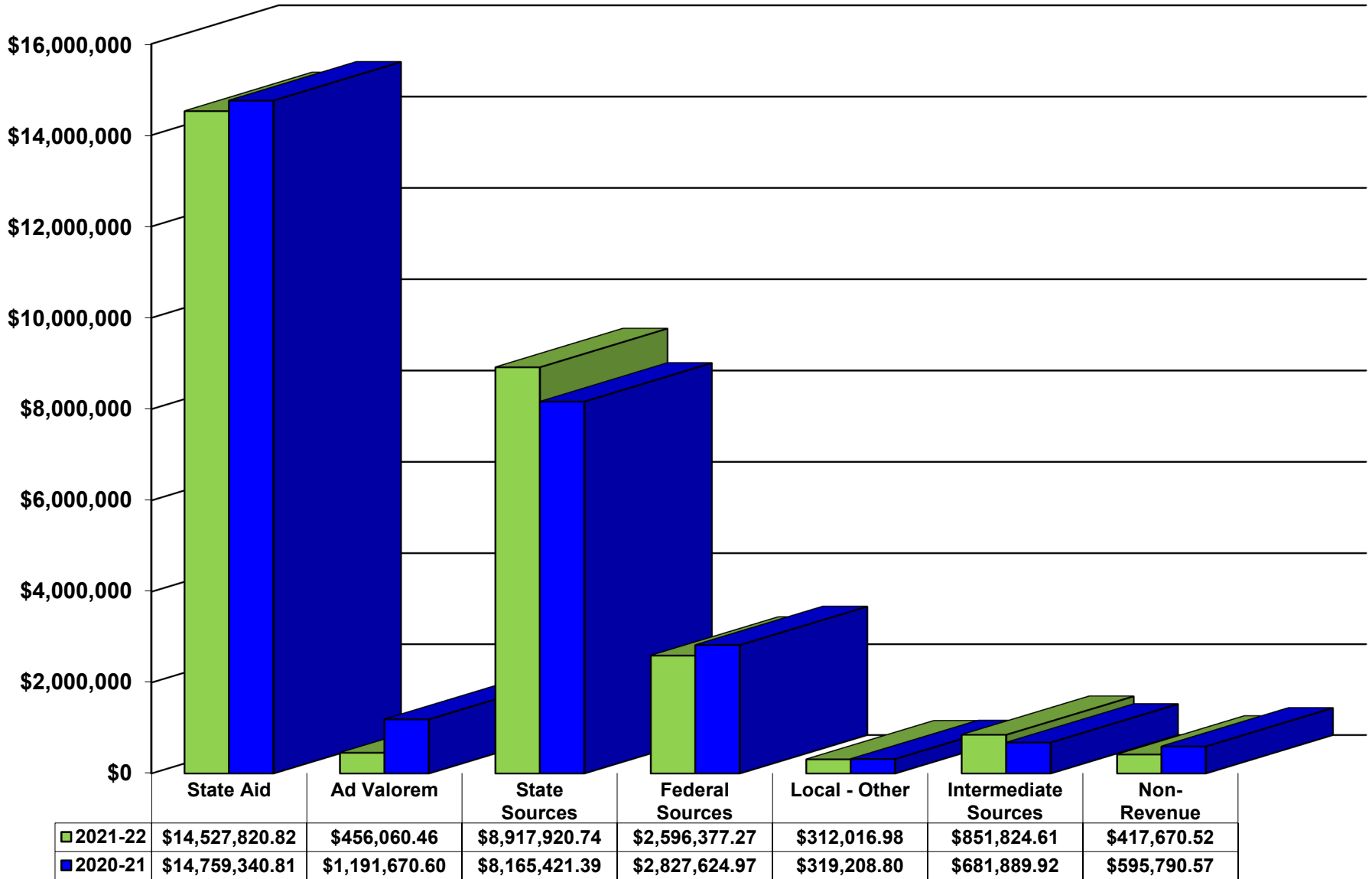

Year-to-Date Revenue

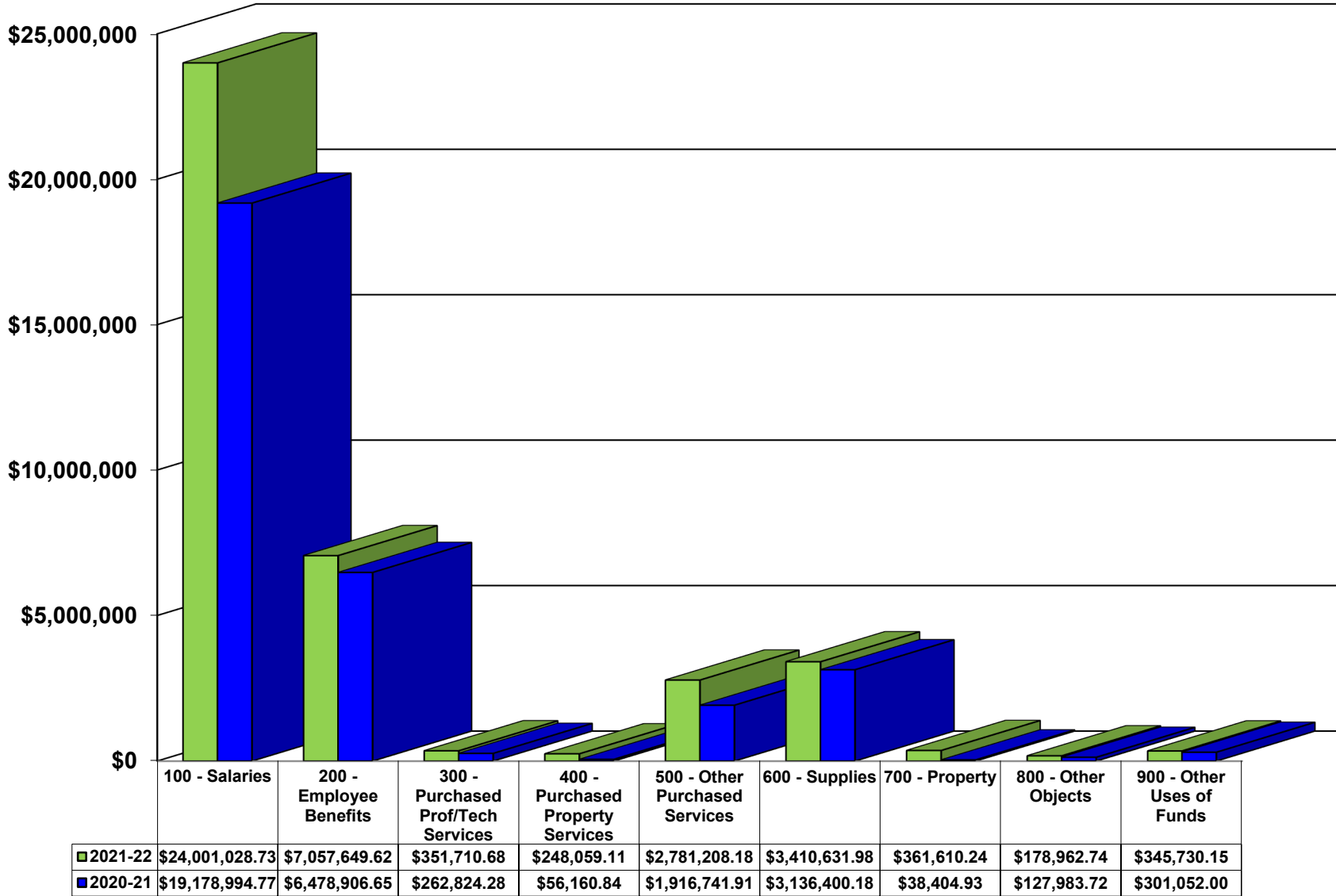

October 2021



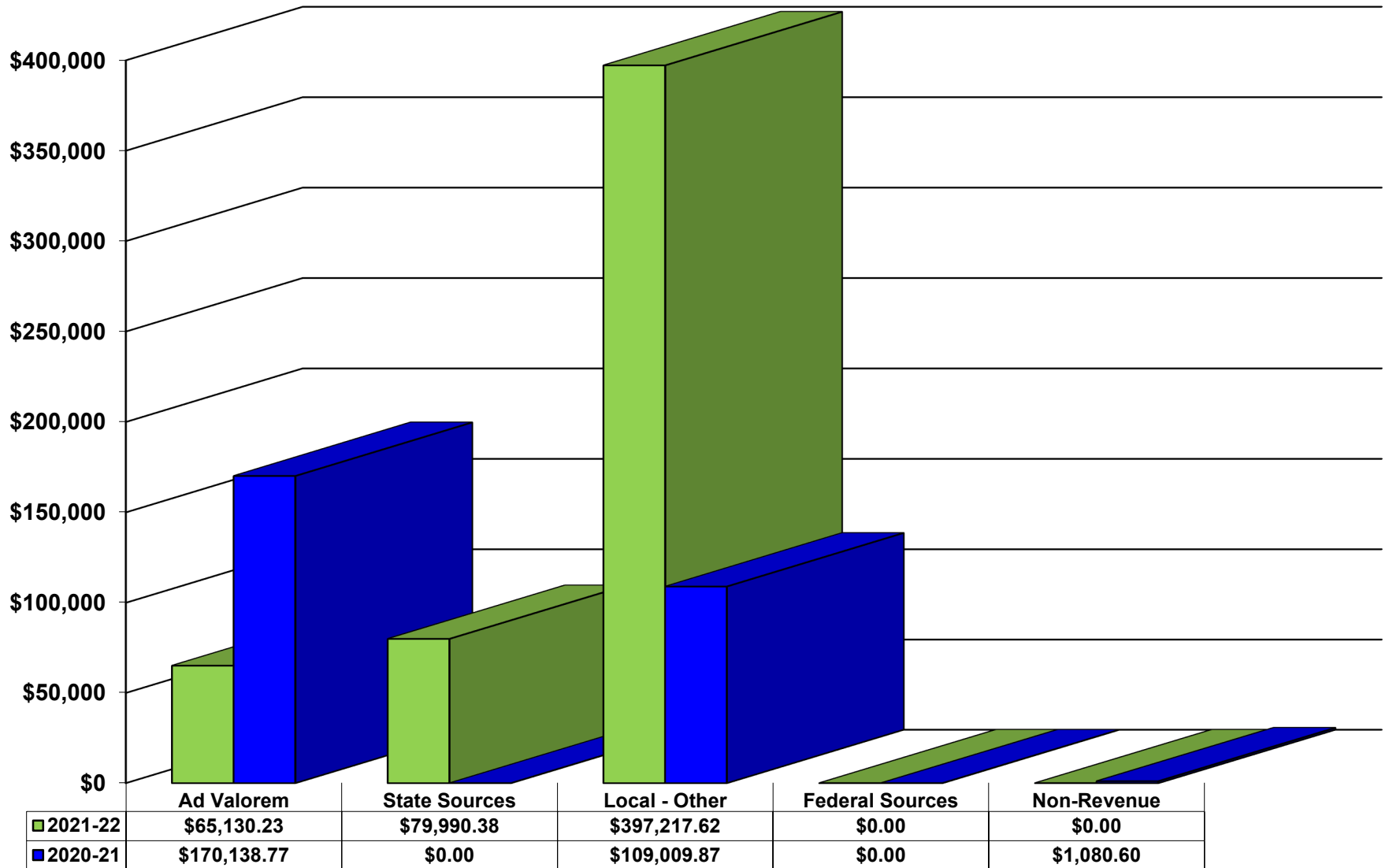

Year-to-Date Revenue

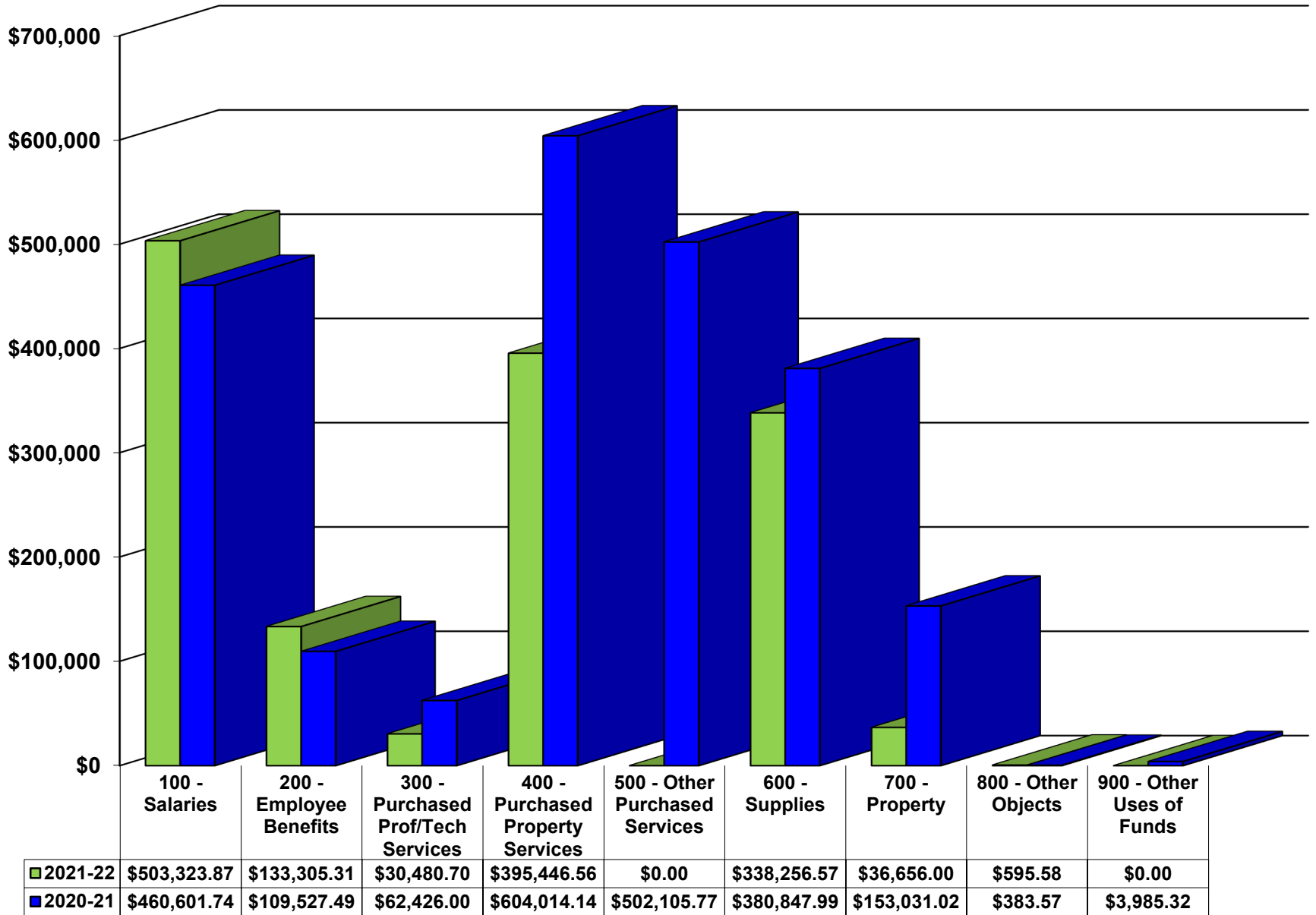

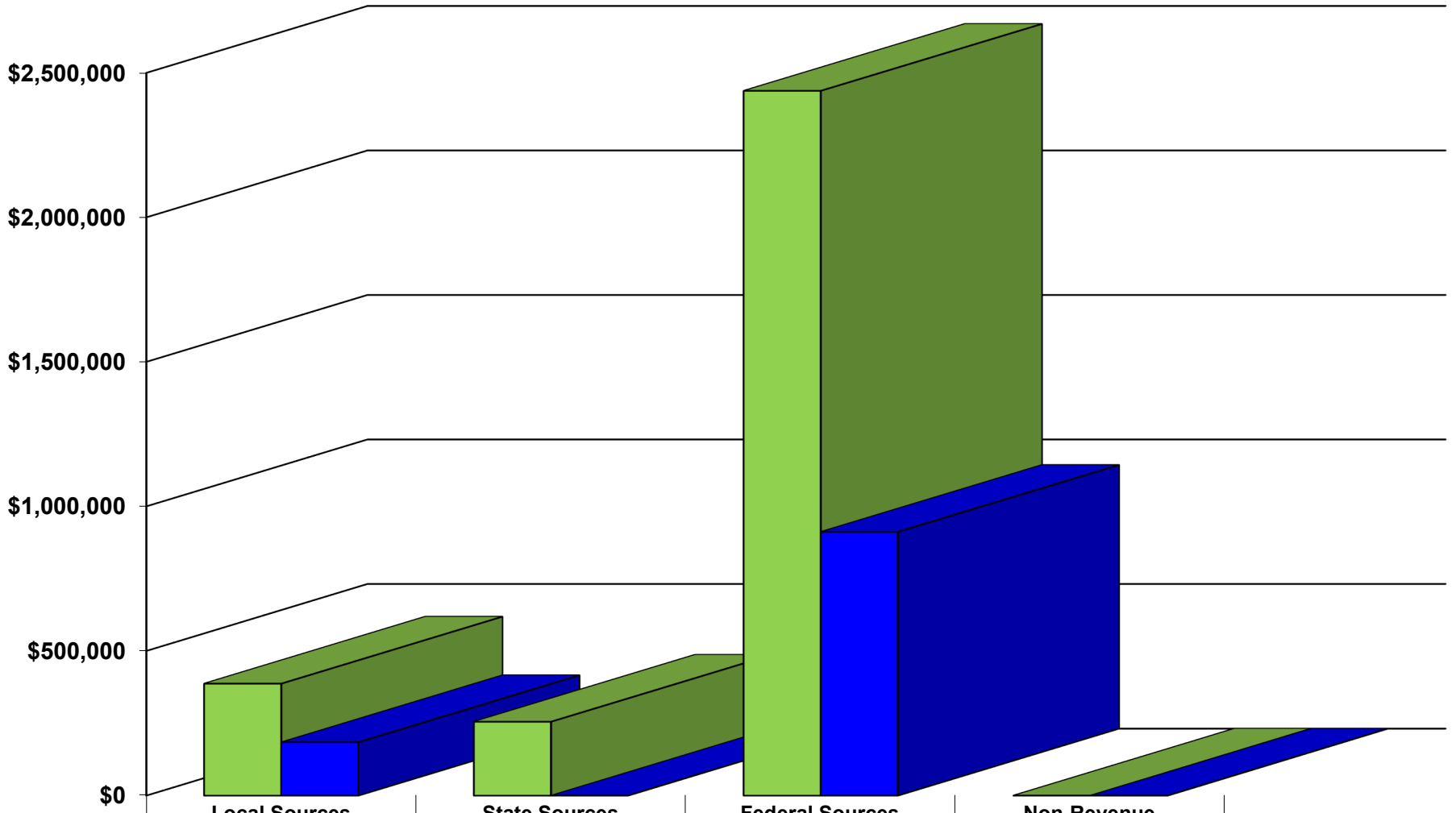

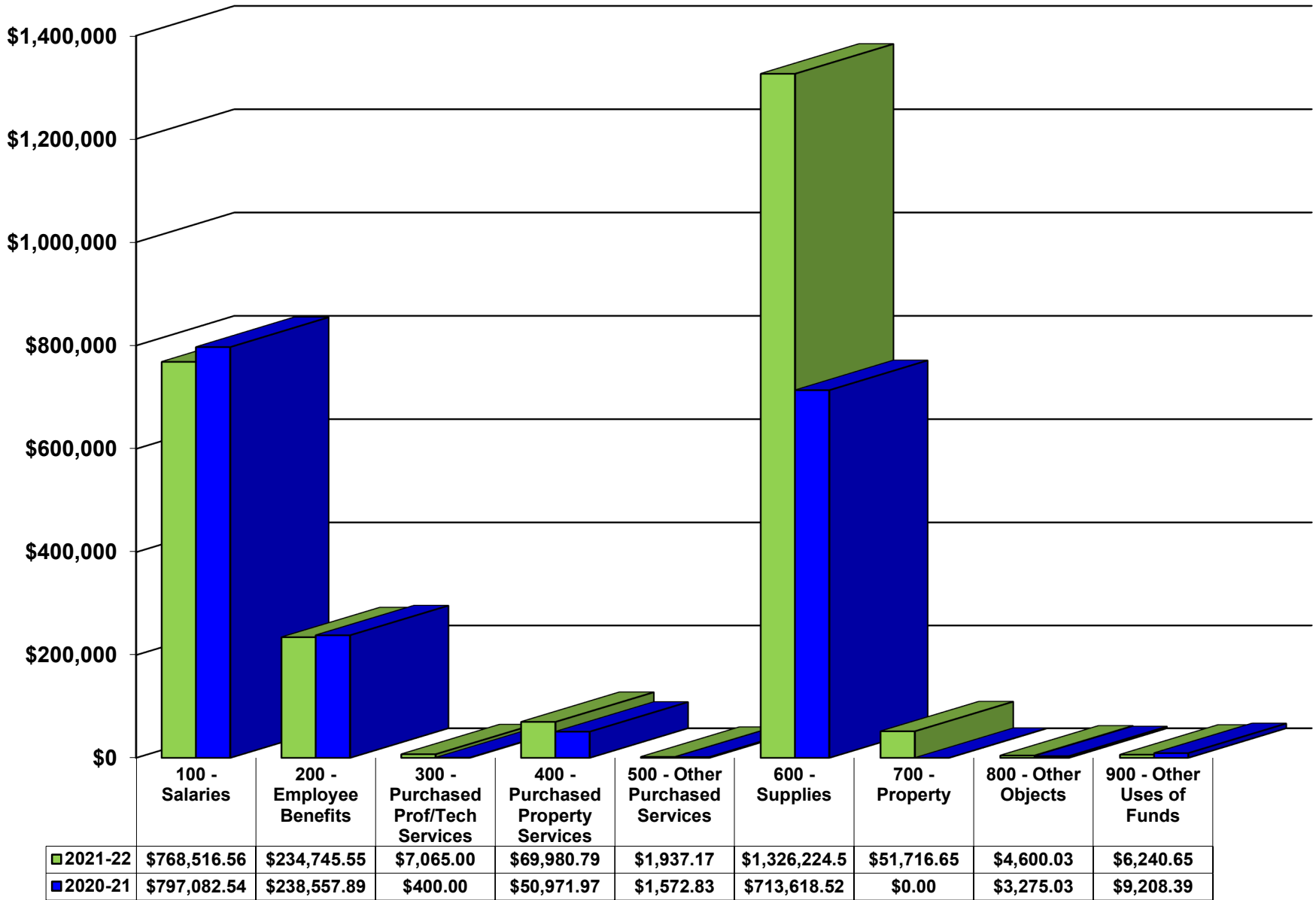
