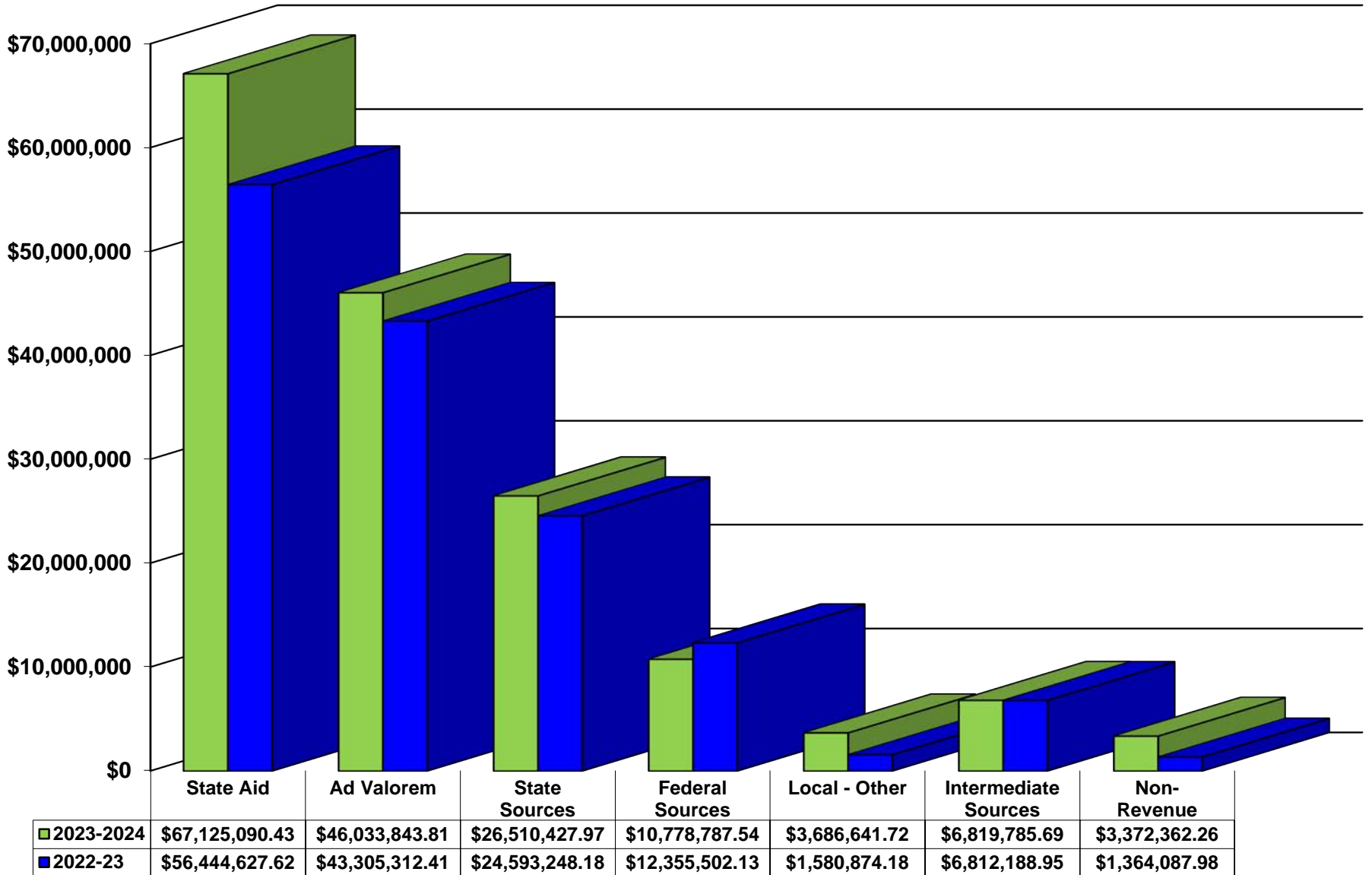

## Year-to-Date Revenue

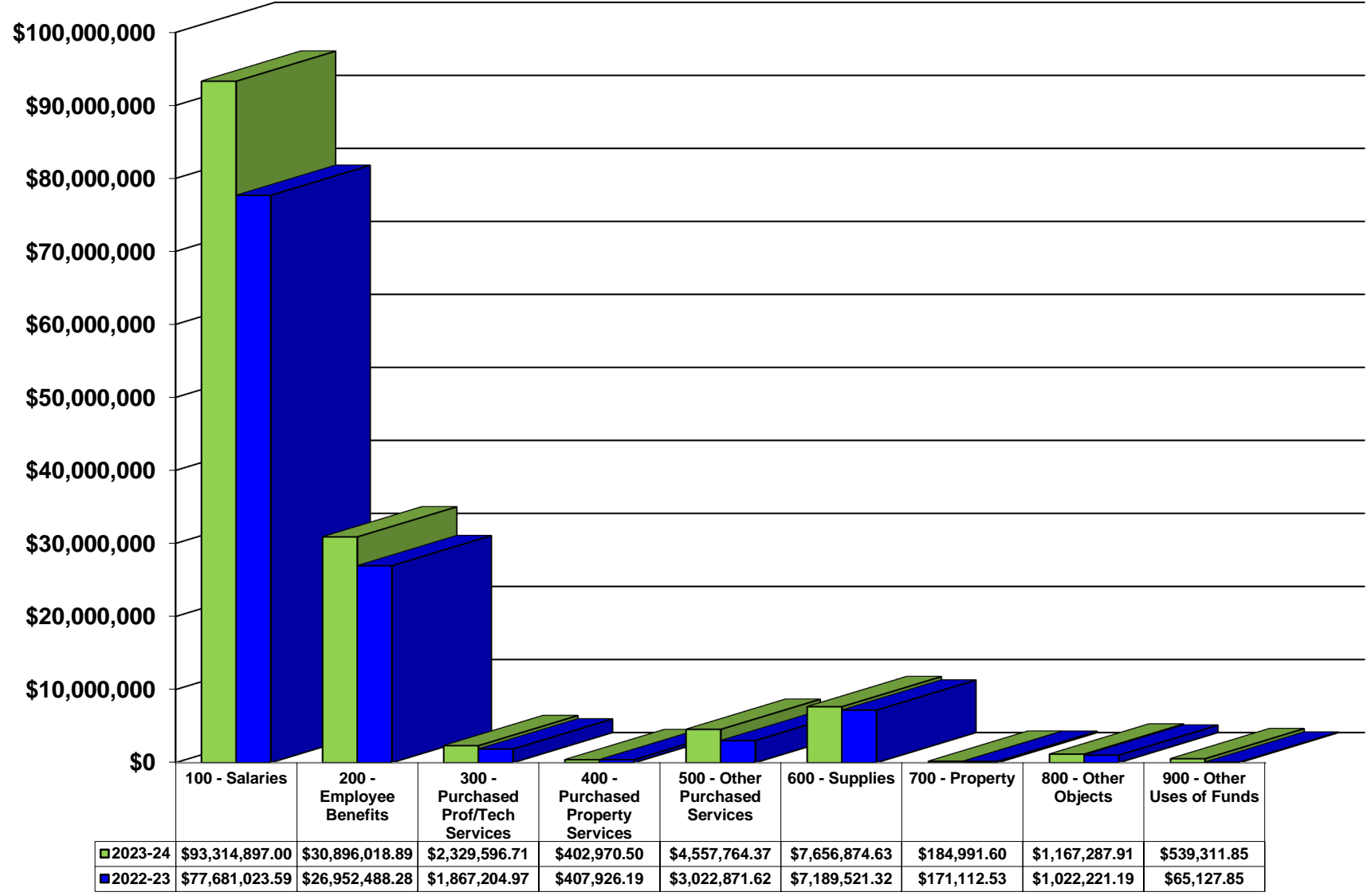

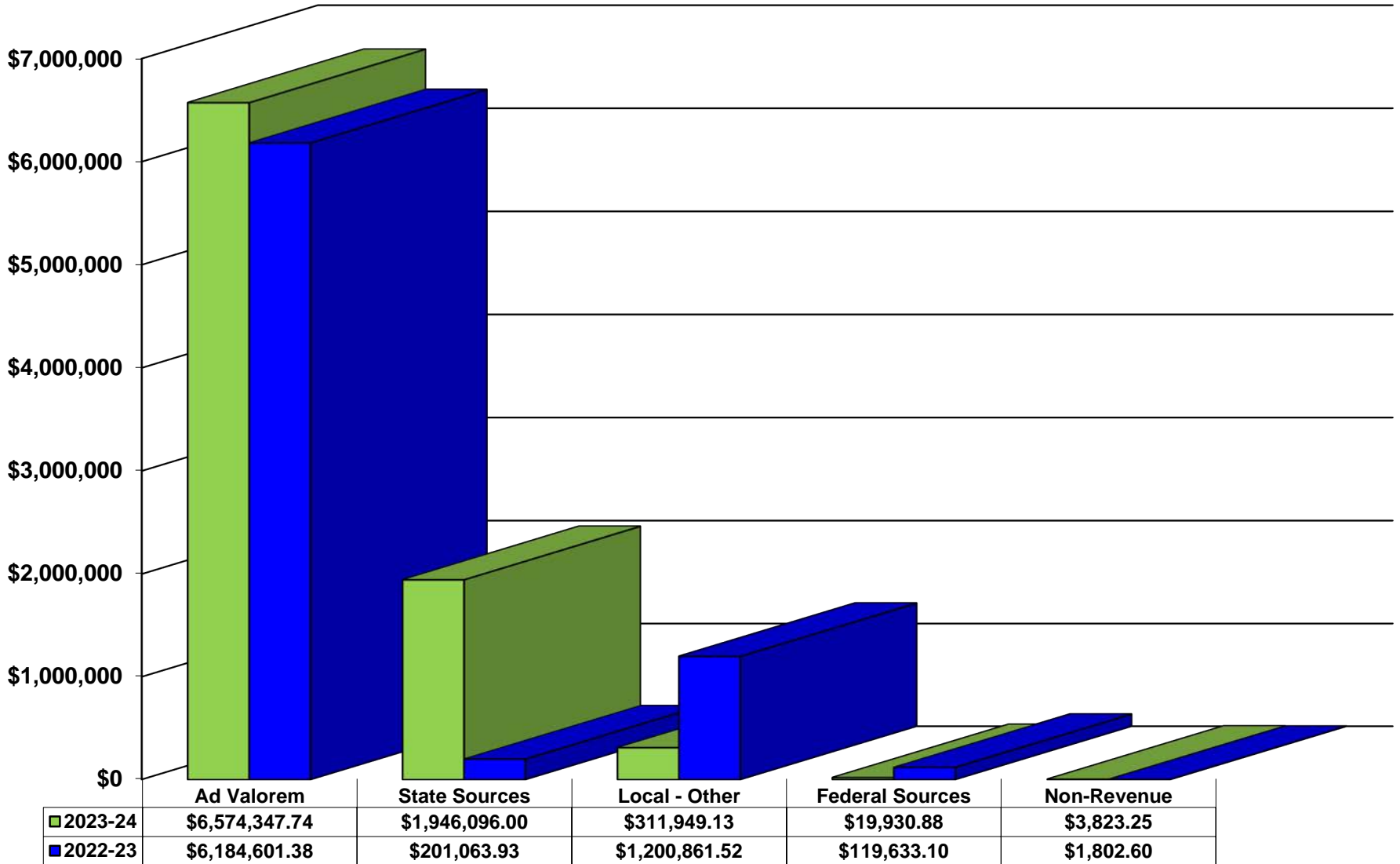

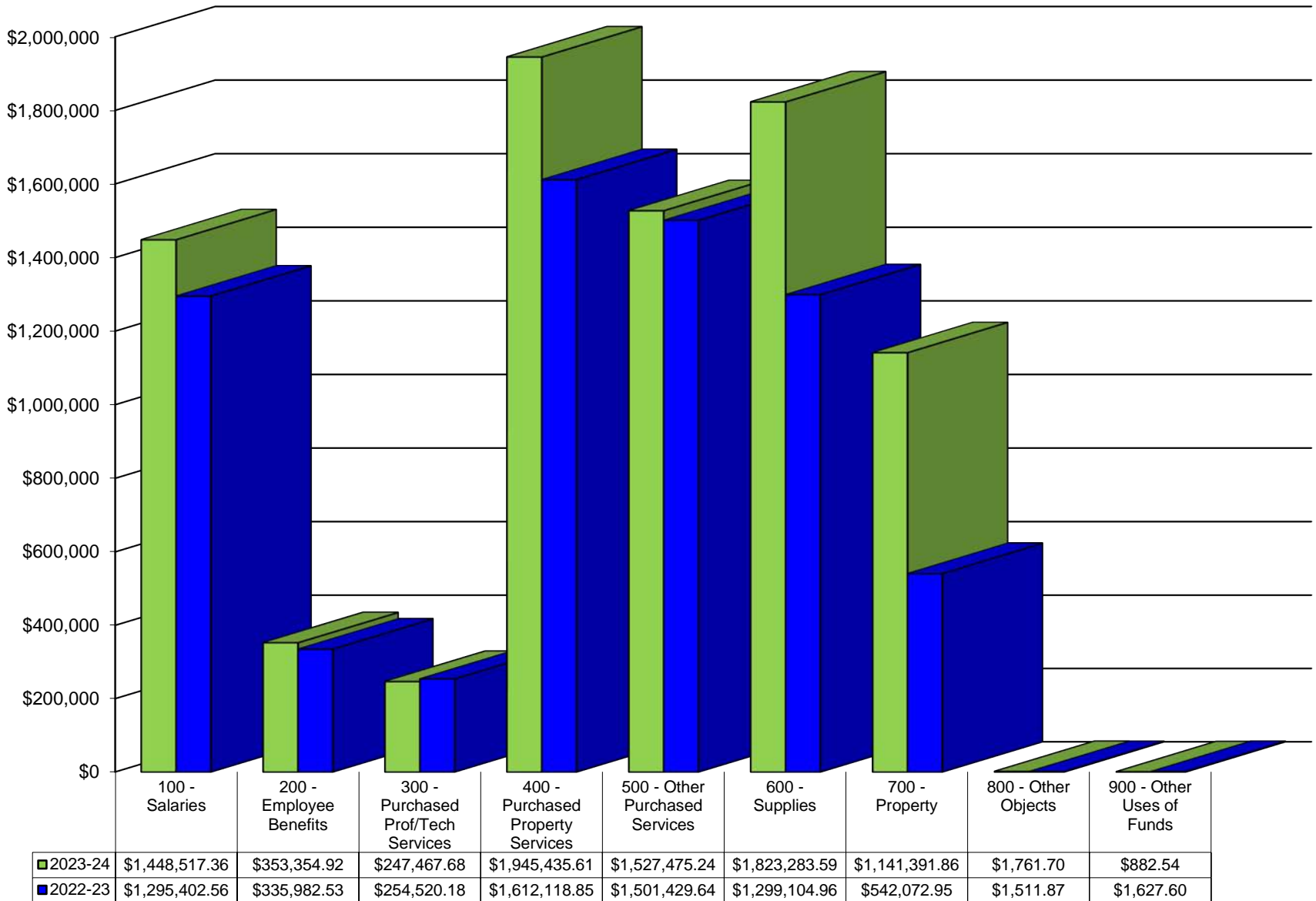

### May 2024



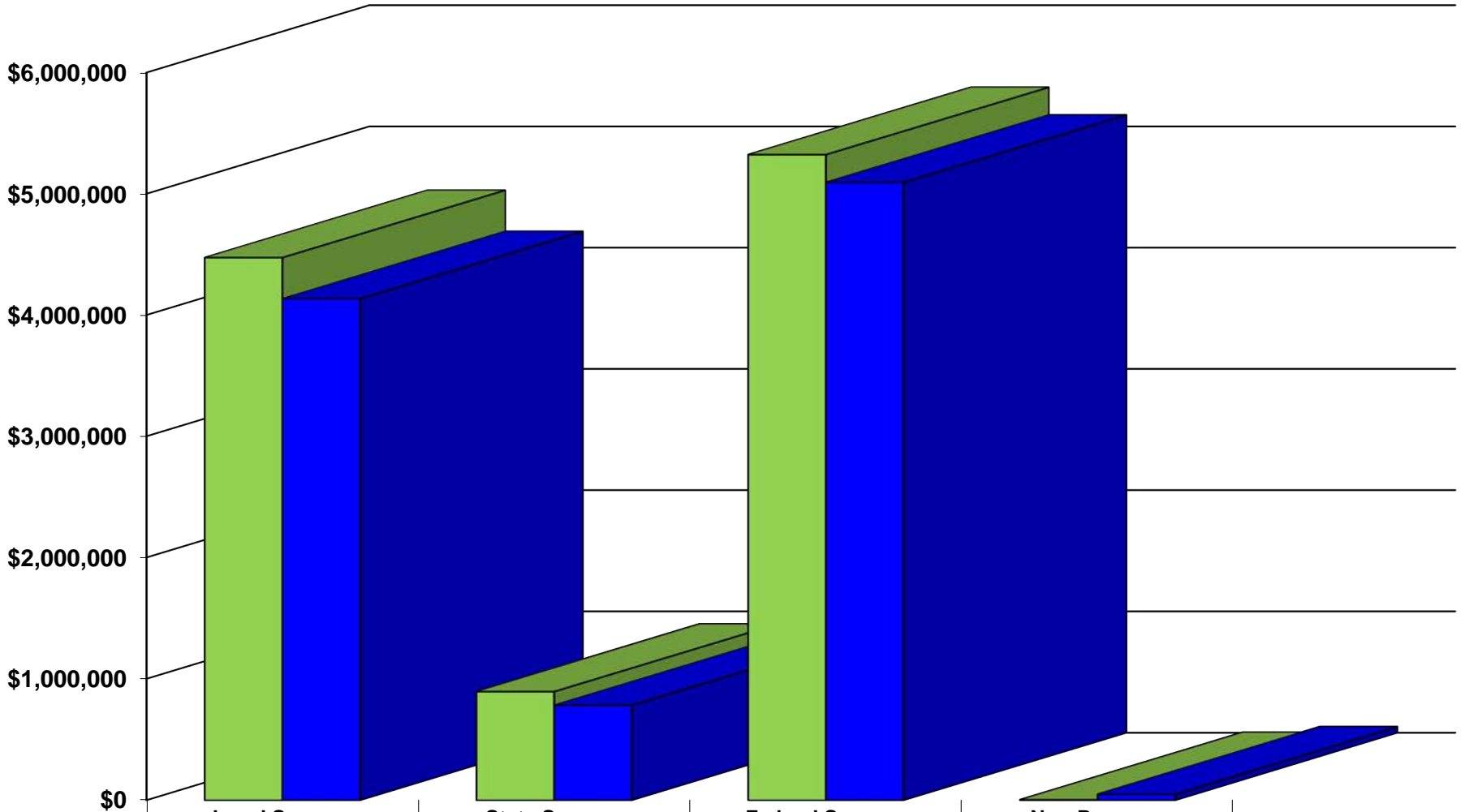

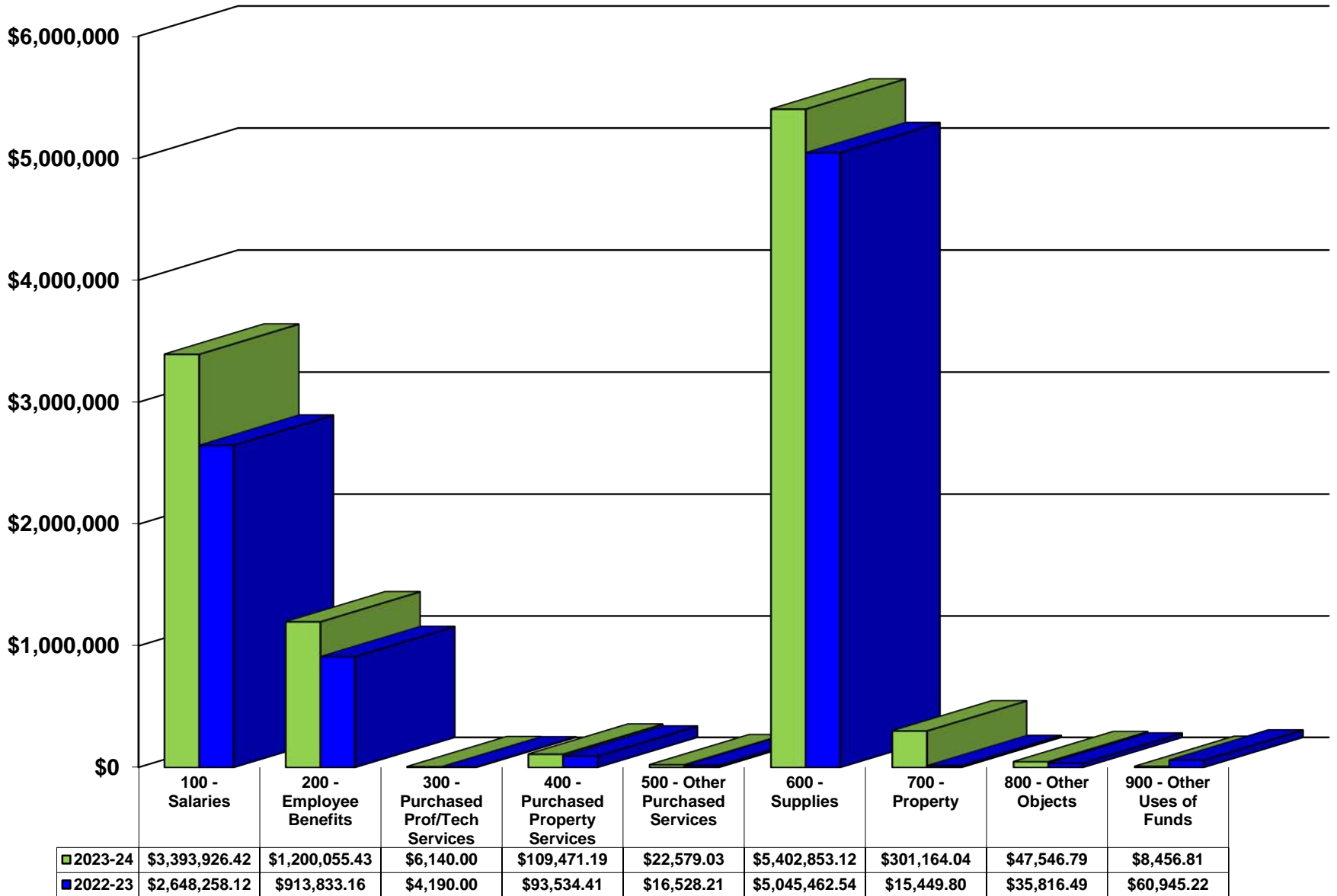
