The general purposes for which this Organization has been established are as follows:

- a) To arouse and maintain an enthusiastic interest in all phases of the Broken Arrow Public Schools (BAPS) Band Program (Band Program).
- b) To help support the band program's financial needs as determined by the Director of Bands.
- c) To support the Band Program and the BAPS in building and maintaining the highest quality instrumental music program possible.
- d) To enable parents and booster club members to support with time and money in an organized fashion that will benefit the students and the Band Program as a whole.
