1. DELIVERY DATE : 04/30/2021 RETURN DATE : 05/02/2021

- 2. This agreement will commence on the day equipment is delivered to customers' premises and terminate upon removal of equipment from premises in good condition.
- 3. Customer will be billed a deposit equal to 50% of the total rental rate upon execution of this agreement. Deposit is non-refundable unless cancellation notice is provided 30 days prior to delivery date. The remainder of rental rate will be due 7 days prior to delivery.
- 4. The customer agrees not to cause equipment to be moved after delivery and set up.
- 5. The customer agrees to exercise care in the use and handling of equipment and will be responsible for any damages to equipment. Customer is responsible for the replacement cost of the equipment, if complete loss occurs, including fire and theft.
- 6. Customer assumes all risk and liability for injury to any person or damage to any property arising from the use, condition, possession or storage of the rented equipment. Customer will indemnify, defend, and hold harmless AYS, its agents and employees for all claims, losses or damages relating to the use of equipment.
- 7. Credit card information (if submitted herewith) is true and accurate and AYS is authorized to use this information for payment of amount billed.
- 8. If Customer is renting a generator from AYS we will deliver full of unleaded fuel and customer will be responsible for all further fuel expenses.
