## RESOLUTION

A RESOLUTION FIXING THE AMOUNT OF BONDS TO MATURE EACH YEAR, FIXING THE TIME AND PLACE THE BONDS ARE TO BE SOLD AND AUTHORIZING THE CLERK TO GIVE NOTICE OF SAID SALE AS REQUIRED BY LAW; AND DESIGNATING BOND COUNSEL FOR THIS ISSUANCE OF BONDS.

WHEREAS, the issuance of \$361,000,000 of Building Bonds by Independent School District Number 3 of Tulsa County, Oklahoma, has been duly authorized at an election held for that purpose and certified by the County Election Board of Tulsa County, Oklahoma on the 13<sup>th</sup> day of February, 2015.

WHEREAS, the Board of Education of Independent School District No. 3 of Tulsa County, Oklahoma, having determined at the time that the election was called to authorize the \$361,000,000 Building Bonds to be issued in separate series, with the first series in the amount of \$2,545,000 Building Bonds, dated April 1, 2012; the next series in the amount of \$145,000 Building Bonds, dated April 1, 2014; the next series in the amount of \$5,200,000 Building Bonds, dated April 1, 2020; the next series in the amount of \$22,000,000 Building Bonds, dated April 1, 2021; the next series in the amount of \$11,000,000 Building Bonds, dated April 1, 2022 and the next series in the amount of \$8,000,000 to be issue immediately; and

WHEREAS, the Board of Education of Independent School District No. 3 of Tulsa County, Oklahoma, hereby employs Terry L. Hawkins of Phillips Murrah P.C., as Bond Counsel for this issuance of bonds.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRICT NUMBER 3 OF TULSA COUNTY, OKLAHOMA:

SECTION 1. That the \$8,000,000 of Building Bonds of Independent School District Number 3 of Tulsa County, Oklahoma, voted on the 10<sup>th</sup> day of February, 2015, shall be offered for sale and that the Board of Education of Independent School District Number 3 of Tulsa County, Oklahoma, will receive bids by sealed bid, facsimile bid, or electronic bid (via PARITY) on the \_\_\_\_\_\_ day of January, 2023, until 11:45 o'clock a.m. and said Bonds shall be awarded by the Board of Education at 12:00 o'clock noon, at the ESC Board Room, Broken Arrow Public Schools, 701 South Main Street, Broken Arrow, Oklahoma, on the \_\_\_\_\_ day of January, 2023, said Bonds to become due \$8,000,000 in two (2) years from their date.

**SECTION 2.** That the Clerk of the Board of Education is hereby ordered and directed to cause notice of the sale of said Bonds to be given as required by law.

**SECTION 3.** The Board of Education of Independent School District No. 3 of Tulsa County, Oklahoma, hereby employs Terry L. Hawkins of Phillips Murrah P.C., as Bond Counsel for this issuance of bonds.
