Amendment #5 to Services Agreement

This Amendment (the "Amendment") is effective as of January 1, 2023 (the "Amendment Effective Date") and amends the HealthiestYou Services Agreement by and between Teladoc, Inc. ("HealthiestYou") and Broken Arrow Public Schools (the "Employer").

WHEREAS, Employer and HealthiestYou are parties to the HealthiestYou Services Agreement dated February 1, 2018, as subsequently amended by an Amendment #1, effective January 1, 2019, an Amendment #2, effective January 1, 2020, an Amendment #3, effective January 1, 2021, and an Amendment #4, effective January 1, 2022 (collectively the "Agreement"); and

WHEREAS, the PEPM fee charged to the Employer shall be adjusted on the Amendment Effective Date.

NOW, THEREFORE, Employer and HealthiestYou agree as follows:

- Existing Agreement. Except as set forth is this Amendment, all terms and conditions of the
 Agreement shall remain in full force and effect. In the event of any conflict between the terms of
 this Amendment and the Agreement this Amendment shall control.
- 2. <u>Amendment to Section 9- Service Fees.</u> As of the Amendment Effective Date, the PEPM fee outlined in Section 9(A) of the Agreement shall remain at \$13.65 and will not be increased prior to December 31, 2023.
